- SCOPE OF WORK:** Sale is on "AS IS WHERE BASIS" and "NO COMPLAINT BASIS". No complaint regarding quality, quantity or composition of the Waste and Scrap material will be entertained. Loading of scrap material into the truck has to be arranged by the tenderer.
- The EMD submitted by you is converted as Security Deposit. This amount will not bear any interest. In case of failure to execute the order, sale order will be cancelled and amount paid as EMD will be forfeited. The EMD paid by the unsuccessful bidders will be refunded within 60 Days.
- PRICE VALIDITY:** The rate quoted should be valid for a **minimum period of 60 days** from the due date of Tender. No bidder is permitted to withdraw their offer within the validity period of the tender or before finalization of the order. In such case EMD will be forfeited & Bidder will be blacklisted.
- The buyer shall be allowed to lift the material only after advance payment for the quantity available including the applicable GST. The remittance has to be made by DD / NEFT / RTGS / IMPS in favour of Tamil Nadu Newsprint and Papers Limited payable at Karur.
- The tentative quantity may vary +/-10% on either side. The delivery of the material will be given only during General shift working hours on working days.
- The buyer is not permitted to resell the material within the factory site. The buyer has to take delivery of the material either by them or their authorized representatives only.
- All taxes due under provisions of local law as applicable at the time of collection of materials shall be payable by Purchaser.
- INSURANCE FOR WORKMEN EMPLOYED BY THE BUYER:** The buyer should submit Insurance Policy under workmen compensation Act / road safety for the staff / workmen engaged for co-ordination / material lifting by them for the entire contract period before commencement of work. TNPL is not responsible for any accidents occurred to employees of buyer/ any other person engaged by the buyer.
- DRIVING LICENCE:** The drivers employed by the buyer shall possess valid driving license and TNPL reserves the right to check these papers and certificate of Insurance as and when required. TNPL is no way be responsible for violation of transport regulations by the buyer and their crew.
- The buyer should strictly follow the safety and security rules & regulations of the company.
- You shall mobilize the necessary manpower including unskilled labour and supervisors for the effective execution of the work with necessary insurance cover for all crew including drivers and cleaners of your vehicles engaged for this work. You shall provide all amenities as per the statutory requirement to them at your cost.
- TNPL shall not be responsible of any accident. Buyer shall provide all amenities to the workmen as per statutory requirement at their cost. Buyer should strictly follow the security, safety rules and regulation of TNPL.
- TNPL reserves the right to withdraw material from sale without assigning any reasons.
- Any dispute arising out of the sale shall be subject to the jurisdiction of the Courts situated in Karur.
- The Buyer shall be responsible to ensure that their employees follow safety regulations and as per TNPL stipulations and other statutory regulations. Buyer shall ensure that all his workmen on site use safety belts, gloves, helmets, masks, Safety Shoes, Goggles etc., as necessary for their safety.

16. Material must be removed by the buyer before stipulated time. Once the materials are taken out of the factory gate, Buyer will be solely responsible for all sort of claims like shortage, missing parts, damage, incident, accident, loss of containers etc.
17. **Cancellation of order and penalty:** In the event of not taking delivery of Waste materials in time, TNPL reserves the right to dispose off the material as it deems fit at their own discretion to any other person and recover any loss due to this from the original buyer. Also in the event of unsatisfactory performance, TNPL reserves the right to cancel the order. In the event of such cancellation, the security deposit will be forfeited and buyer will be put under defaulters list. In addition, TNPL also reserves the right to recover such amounts as it deems fit from the buyer towards the breach of contract and due to unsatisfactory performance. TNPL's decision will be final and binding.
18. Buyer and his men are subject to the security rule of TNPL in force while in the TNPL premises. buyer's workmen, agents or representatives shall not commit any nuisance, theft or indulge in any anti-social activities in the premises and the Buyer shall be liable for the good conduct, safety and discipline of his workmen. In case of any such activity, delivery will be suspended and strict action as per law will be taken including forfeiture of EMD.
19. Any damage caused to the equipment of TNPL due to negligence on your part/ workmen/vehicles shall be repaired/replaced and the cost thus incurred shall be debited to your account.
20. Emission Test certificate issued by a testing agency authorized by Transport department of T.N to comply emission norms (except Tractor) has to be provided to TNPL for vehicle engaged for transporting of the waste material.
21. **Subletting of contract:** The buyer shall not assign or sublet the order or any part thereof or allow any person to become interested therein in any manner, whatsoever, without specific /written permission from TNPL.
22. **VALIDITY:** The Order shall be kept valid for a period of One year from the date of sale order. The order may be extended upto one month. TNPL reserves the right to reduce the contract period and to cancel the order depending upon the necessity at its own discretion without assigning any reasons after giving a 15 days notice.
23. The Buyer should produce the GSTIN & PAN Numbers and a copy of the Registration certificate along with Tender.
