



- The submitting tender envelope need to be super scribing the TENDER NO and DUE DATE and addressed to THE AGM(STORES), TAMILNADU NEWSPRINT AND PAPERS LIMITED, UNIT-2, Mondipatti, Trichy Dist., Pin: 621 306, Tamilnadu and deposit the tender envelopes in Tender box at TOS dept.
- The due date for submission of your offer is 17.05.2023 at 3.00 PM. Offers received after 3.00 PM will not be considered. Tender will be opened in the presence of interested bidders on 17.05.2023 at 4.00 PM.
- The tenders submitted by tenderers those who have already been black listed by TNPL shall be returned as unopened.

- 1. SCOPE OF WORK: Collection, Loading and Transportation of subject item (Wood billets, Root stumps and Branches) from plantation and industrial area. Necessary truck/tractor need to be arranged by the contractor for this scope of work. Loading time shall be between 8.30 Am to 5.30 PM only.
- The EMD submitted by the successful tenderer will not bear any interest. In case
 of failure to execute the order, sale order will be cancelled and amount paid as
 EMD will be forfeited. The EMD paid by the unsuccessful bidders will be refunded
 within 60 Days through NEFT.
- 3. PRICE VALIDITY: The firm price offer should be kept valid for acceptance for a period of 60 days from the date of opening of price bid whichever is later. No tenderer is permitted to withdraw their offer within the validity period of the tender or before finalization of the order. In such case EMD will be forfeited & tenderer will be blacklisted.
- 4. The rates offered by the highest tenderer will remain firm throughout the contract.
- 5. ORDER VALIDITY: The Sale Order is valid for a period of Six Months from the Sale Order date.
- 6. PAYMENT TERMS: The tenderer shall be allowed to lift the above material only after 100% advance payment for quantity to be lifted for the day including applicable taxes and duties. The remittance has to be made by "Demand Draft" in favor OF TAMIL NADU NEWSPRINT AND PAPERS LIMITED PAYABLE AT TRICHY. (or) RTGS to TNPL Account.

GENERAL TERMS AND CONDITIONS

- 1. The above items can be inspected at our site on any working day between 10.00AM and 04.00 PM.
- 2. Rights of participation will be for people who after inspecting the material, pre qualify themselves by paying the EMD and who have not been previously blacklisted by TNPL. Final decision regarding participation will be with TNPL.
- 3. Sale confirmation, Sale Order, Invoices etc. will be released only in the name of the tenderer who has initially registered and participated in the tender. There will not be any change between the registration and completion of transaction.
- 4. While taking delivery of the above material, if any damage is caused to the TNPL property or other machinery lying nearby, the TNPL shall recover all such costs from the buyer required to reinstate the damage into the original position and stop delivery of the material till all the costs are paid.

5. INSURANCE FOR WORKMEN EMPLOYED BY THE TENDERER:

The tenderer should submit Insurance Policy under workmen compensation Act for the staff / workmen engaged for co-ordination / material lifting by them for the entire contract period before commencement of work. TNPL is not responsible for any accidents occurred to workmen or any other person engaged by the tenderer for this contract.

- 6. DRIVING LICENCE: The drivers employed by the tenderer shall posses' valid driving license and TNPL reserves the right to check these papers and certificate of Insurance as and when required. TNPL in no way be responsible for violation of transport regulations by the tenderer and their crew.
- 7. The tenderer shall be responsible to ensure that their employees follow safety regulations as per TNPL stipulations and other statutory regulations. Tenderer shall ensure that all his workmen on site use safety belts, gloves, helmets, masks, Safety Shoes, Goggles etc., as necessary for their safety.
- 8. Once the above Material is taken out of the factory gate, tenderer will be solely responsible for all sort of claims like shortage, missing parts, damage, incident, accident, etc.
- 9. Should the tenderer wish to take delivery of the above material through a representative, he must authorize the latter by a letter of authority, which shall be presented to the officer concerned. The officers concerned may in his entire discretion decline to act on any such authority and it shall be for the Tenderer to satisfy the officer concerned that the authority is genuine. Delivery to such person shall be sole responsibility of the tenderer and no claim shall lie against the Company on any account whatsoever, if delivery is offered to a wrong person.
- 10. Tenderer and his men are subject to the security rule of TNPL in force while in the TNPL premises. Tenderer's workmen, agents or representatives shall not commit any nuisance, theft or indulge in any anti-social activities in the premises and the tenderer shall be liable for the good conduct, safety and discipline of his workmen. In case of any such activity, delivery will be suspended and strict action as per law will be taken including forfeiture of EMD.
- 11. In case of any dispute regarding the contract, the decision of the Company shall be final and binding. If there is any dispute as to the last or highest bid, the dispute shall be determined by the company and their decision shall be final and binding to all. Any dispute arising out of the sale shall be subject to jurisdiction of the Courts situated at Trichy.
- **12. Subletting of contract:** The tenderer shall not assign or sublet the order or any part thereof or allow any person to become interested therein in any manner, whatsoever, without specific /written permission from TNPL.
- 13. Cancellation of order and penalty: In the event of not taking delivery of above Material in time, TNPL reserves the right to dispose of the material as it deems fit at their own discretion to any other person and recover any loss due to this from the original tenderer. Also in the event of unsatisfactory performance, TNPL reserves the right to cancel the order. In the event of such cancellation, the security deposit & EMD amounts will be forfeited. In addition, TNPL also reserves the right to recover such amounts as it deems fit from the tenderer towards the breach of contract and due to unsatisfactory performance. TNPL's decision will be final and binding.

- **14. Commencement of work**: The tenderer shall commence the work immediately within 3 days on receipt of intimation /award of sale order.
- 15. Tenders liable for rejection:

The following tenders are liable for rejection summarily:

- a. Tenders submitted by Tenderers who resort to canvassing.
- b. Tenders who do not fulfill all or any of the condition laid down in the tender document.
- c. Tenders, which contain uncalled remarks and
- d. Tenders received after due date and time.
- **16. Rejection of Tender:** TNPL will not assign any reason for rejection of any tender. TNPL shall have the right to reject any or all tenders/ to split order on two or more tenderers / to go for re-tender without assigning any reason / to release order on part quantity
- 17.TNPL not responsible for tenderer employees: The tenderer may employ such employees as he may think fit and the employees so employed shall be the employees of the tenderer, for all purposes, whatsoever, and shall not be deemed to be in the employment of TNPL for any purpose, whatsoever. If under any circumstances whatsoever, TNPL is held liable or responsible in any manner, whatsoever for the default or omission of the tenderer TNPL shall be reimbursed by the tenderer for the same, as also any other expenses or cost incurred by TNPL in any proceedings or litigation as a result of any such claim, demand or act on the part of the employees / representative of the tenderer.
- **18**. In case the Partners or Directors or Proprietor of the Company is/are any relative of any of the employee of TNPL, a declaration to this effect giving the details of the Name of the Employee, Relationship, etc., should be provided separately.
