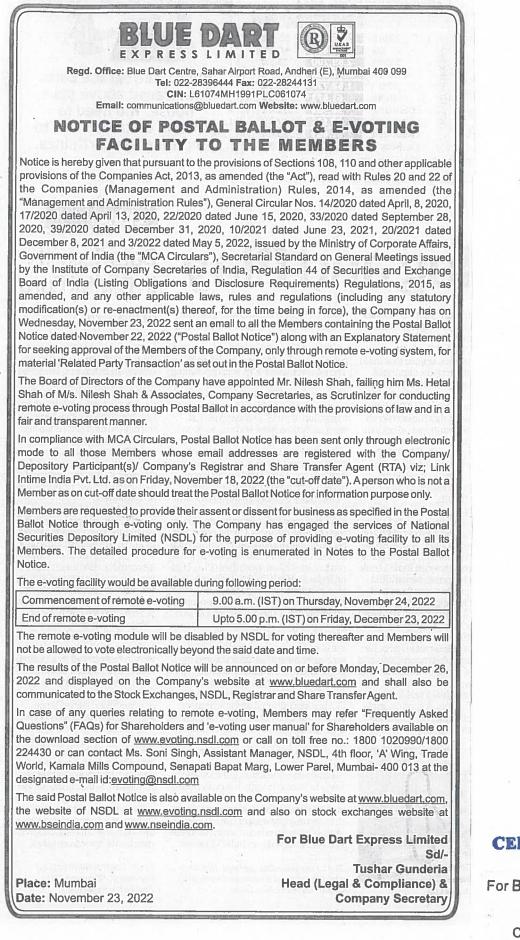

## NOTICE OF POSTAL BALLOT & E-VOTING FACILITY TO THE MEMBERS

Notice is hereby given that pursuant to the provisions of Sections 108, 110 and other applicable provisions of the Companies Act, 2013, as amended (the "Act"), read with Rules 20 and 22 of the Companies (Management and Administration) Rules, 2014, as amended (the "Management and Administration Rules"), General Circular Nos. 14/2020 dated April, 8, 2020. 17/2020 dated April 13, 2020, 22/2020 dated June 15, 2020, 33/2020 dated September 28, 2020, 39/2020 dated December 31, 2020, 10/2021 dated June 23, 2021, 20/2021 dated December 8, 2021 and 3/2022 dated May 5, 2022, issued by the Ministry of Corporate Affairs, Government of India (the "MCA Circulars"), Secretarial Standard on General Meetings issued by the Institute of Company Secretaries of India, Regulation 44 of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended, and any other applicable laws, rules and regulations (including any statutory modification(s) or re-enactment(s) thereof, for the time being in force), the Company has on Wednesday, November 23, 2022 sent an email to all the Members containing the Postal Ballot Notice dated November 22, 2022 ("Postal Ballot Notice") along with an Explanatory Statement for seeking approval of the Members of the Company, only through remote e-voting system, for material 'Related Party Transaction' as set out in the Postal Ballot Notice.

The Board of Directors of the Company have appointed Mr. Nilesh Shah, failing him Ms. Hetal Shah of M/s. Nilesh Shah & Associates, Company Secretaries, as Scrutinizer for conducting remote e-voting process through Postal Ballot in accordance with the provisions of law and in a fair and transparent manner.

In compliance with MCA Circulars, Postal Ballot Notice has been sent only through electronic mode to all those Members whose email addresses are registered with the Company/ Depository Participant(s)/ Company's Registrar and Share Transfer Agent (RTA) viz; Link Intime India Pvt. Ltd. as on Friday, November 18, 2022 (the "cut-off date"). A person who is not a Member as on cut-off date should treat the Postal Ballot Notice for information purpose only.

Members are requested to provide their assent or dissent for business as specified in the Postal Ballot Notice through e-voting only. The Company has engaged the services of National Securities Depository Limited (NSDL) for the purpose of providing e-voting facility to all its Members. The detailed procedure for e-voting is enumerated in Notes to the Postal Ballot Notice.
