I am writing to you under the Freedom of Information Act 2000 to request the following information for the Project

3. Price/Cost Proposed by each Bidder – we want this information for all the bidders who submitted the response.
4. Name of the Winning Bidder.
5. Name & Rank of all bidders who submitted responses.
6. Approximate date that the tender will be reissued towards the end of the current contract period.

DoF response

The Department has completed its search in relation to the above questions.

I can confirm the department holds some of the information requested, however some information has been withheld as it falls within an exemption. Further details are provided below in the order of the aforementioned requests.

1. The information requested is withheld under Section 43(2) (Commercial Interests) of the Freedom of Information Act (FOIA) as the disclosure of this information under the Act would or would be likely to prejudice the commercial interests of the Tenderers and the department.
