AMENDMENT #1 OF SHIPPING SERVICES CONTRACT BETWEEN THE UNITED STATES POSTAL SERVICE AND

REGARDING FIRST-CLASS PACKAGE SERVICE

WHEREAS, the United States Postal Service (the "Postal Service") and

("Customer") entered into a Shipping Services Contract, FCPS Contract 87/Docket No. CP2018-98 regarding First-Class Package Service on December 11, 2017 ("Contract").

WHEREAS, the Parties desire to amend the terms in Section I.B, including new Table A, Sections I.E, I.F, including new Tables A.1 and A.2 and Section IV of the Contract.

NOW, THEREFORE, the Parties agree that the Contract is hereby amended as detailed below. The existing Contract remains unchanged in all other respects. This amendment #1 ("Amendment") shall become effective three (3) business days following the day on which the Commission issues all necessary regulatory approval ("Amendment Effective Date"). Capitalized terms that are not defined in this Amendment will have the meanings given to them in the Contract.

I. Terms

E. The Parties agree to a non-binding good faith estimate of at least Class Package Service packages shipped under this Contract from July 1, 2023 through September 30, 2023.

F. Contract Prices.

1. The following prices apply to Customer's Contract Packages from the Amendment Effective Date through June 30, 2023.



2. The following prices apply to Customer's Contract Packages beginning July 1, 2023 through September 30, 2023.



² Beginning July 1, 2023, Contract Package prices found in Table A.2 will apply to First-Class Package Service ounce-based Contract Packages. Beginning July 9, 2023, the prices found in Table A.2 will apply to USPS Ground Advantage ounce-based Contract Packages.



IV. Expiration, Termination, and Extension

- A. Expiration. This Contract will expire on September 30, 2023, unless (1) terminated by either Party with ninety (90) calendar days' notice to the other Party in writing pursuant to Section IV.B; (2) superseded by a subsequent contract between the Parties; (3) ordered by the Commission or a court; or (4) otherwise required to comply with subsequently enacted legislation.
