The Postal Service hereby provides notice that the terms of Priority Mail Express, Priority Mail, First-Class Package Service & Parcel Select Contract 14, in the above-captioned proceeding, have changed as contemplated by the contract's terms. A redacted version of the amendment to Priority Mail Express, Priority Mail, First-Class Package Service & Parcel Select Contract 14 is provided in Attachment A, and the unredacted amendment is being filed under seal. The amendment will become effective three business days following the day that the Commission completes its review of this filing.

WHEREAS, the United States Postal Service (the “Postal Service”) and [REDACTED] (“Customer”) entered into a Shipping Services Contract, Priority Mail Express, Priority Mail, First-Class Package Service & Parcel Select Contract 14/Docket No. CP2022-77, regarding Priority Mail Express, Priority Mail, First-Class Package Service & Parcel Select, on June 1, 2022.

WHEREAS, the Parties desire to amend the terms in Sections I.B and I.J of the Contract.

NOW, THEREFORE, the Parties agree that the Contract is hereby amended as detailed below. The existing Contract remains unchanged in all other respects. This Amendment shall become effective three (3) business days following the day on which the Commission issues all necessary regulatory approval.

**I. Terms**

**B. Applicable Products**

This Contract applies to Contract Packages, defined in Section I.C, shipped using the following products with the following limitations, and excluding packages originating from and/or addressed to ZIP Codes contained in Table A below, as follows (collectively, “Contract Packages”):

1. Priority Mail Express weight-based packages that do not exceed [REDACTED]; [REDACTED];
2. Priority Mail Express Flat Rate Envelopes [REDACTED];
3. Priority Mail weight-based packages that do not exceed [REDACTED]; [REDACTED];

4. Priority Mail cubic packages that do not exceed [REDACTED];
  5. Priority Mail Flat Rate Envelopes [REDACTED];
  6. Priority Mail Flat Rate Boxes [REDACTED];
  7. First-Class Package Service – Commercial packages that do not exceed [REDACTED]<sup>1</sup>;
  8. Parcel Select Ground weight-based packages, excluding [REDACTED] packages, that do not exceed [REDACTED]<sup>2</sup>;
  9. Parcel Select Ground cubic packages that do not exceed [REDACTED]<sup>3</sup>;
  10. First-Class Package Service – Commercial weight-based packages, excluding [REDACTED] packages, weighing at least [REDACTED]; and
  11. First-Class Package Service cubic packages that do not exceed [REDACTED]<sup>5</sup>.

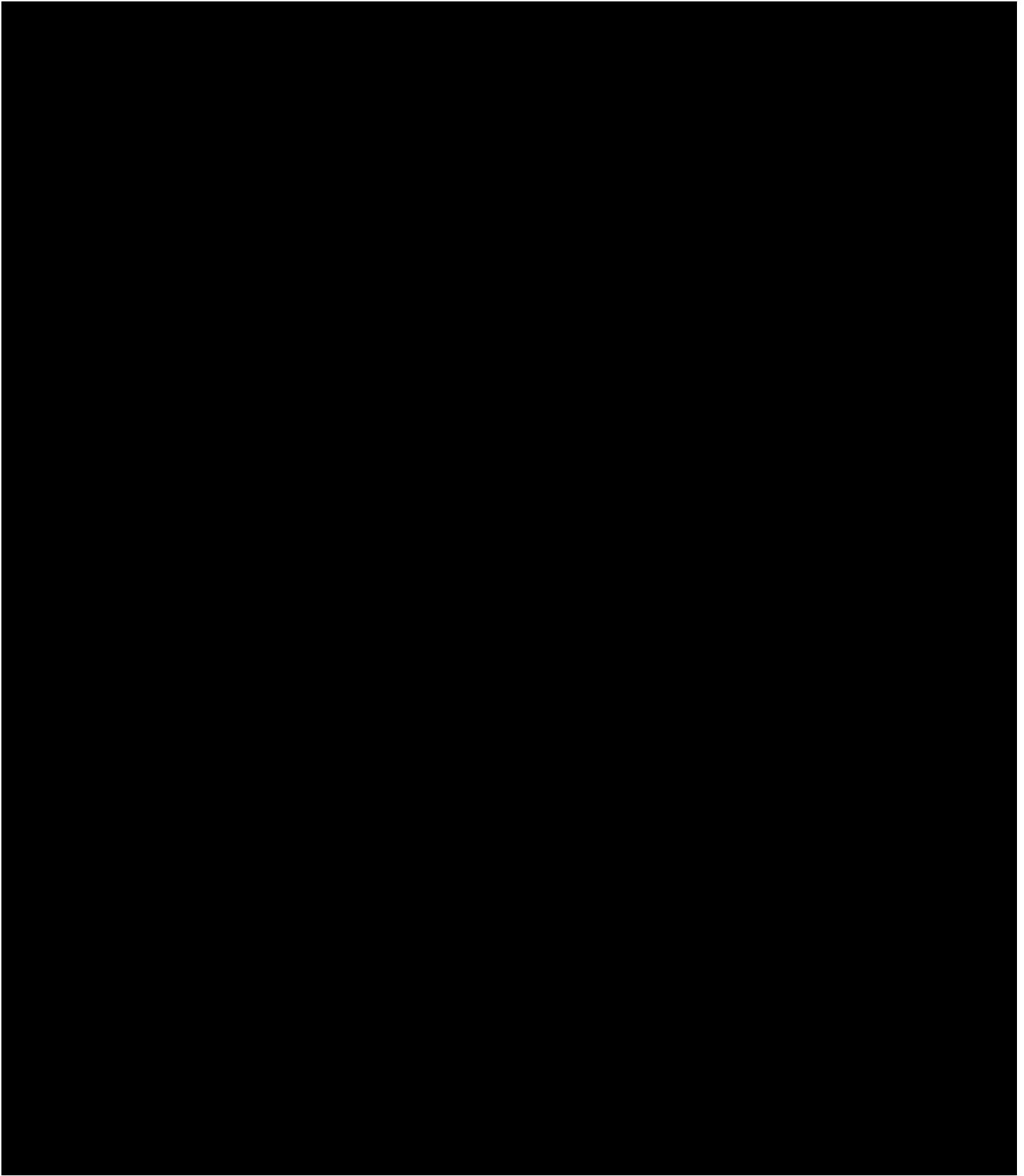
