Thank you for your correspondence of January 5th, 2024 where you advised TBL Group, Inc. under 49 CFR 1103.3 and 49 CFR 1104.4, that we needed to correct our filing, which is currently in abeyance.

Additionally, thank you and the board's consideration where supplemental information could be provided in reference to Docket Number 21113.

JKS Limousines, LLC is the only USDOT-regulated passenger-carrier transportation company that is being acquired pursuant to 49 USC Section 14303 by TBL Group, Inc. and shall be incorporated as Echo Windy City, LLC.

Echo Windy City, LLC will be a subsidiary of TBL Group, Inc. All purchased assets from JKS Limousines, LLC and insurance requirements shall be under the name of Echo Windy City, LLC.

Windy City Limousine Company, LLC is not a USDOT-regulated passenger-carrier company and is no longer named as a "DBA" of JKS Limousines, LLC on its MCS-150 filings with the Federal Motor Carrier Safety Administration.

TBL Group, Inc. completed an exhaustive effort to demonstrate the legal relationship between Windy City Limousine Company, LLC and JKS Limousines, LLC.

Based on TBL Group, Inc.'s thorough review, we could not establish the necessary documentation, as a part of this supplemental filing where Windy City Limousine Company, LLC is legally connected to JKS Limousines, LLC. The review was completed for the purpose of this federal docket.

Based on TBL Group, Inc.'s review of all available legal documentation, our application is solely based on the purchase of JKS Limousines, LLC as a federally-regulated passenger-carrier transportation company and is not including Windy City Limousine Company, LLC since:

(1) Windy City Limousine Company, LLC does not hold any state or federal operating authority

(2) Windy City Limousine Company, LLC does not hold the requisite requirements demonstrating its insurance as a federally-regulated passenger-carrier transportation company pursuant to 49 CFR

1182.2

(3) We have attached JKS Limousines, LLC's insurance documentation that is on file with the Federal Motor Carrier Safety Administration of which also demonstrates that the Federal Motor Carrier has verified its \$5 million insurance requirements are on file as a part of its MCS-150 filings

 - a. Echo Windy City, LLC USDOT 4157935 also known as JKS Limousines, LLC USDOT Number 1474787


The corporate governance begins with TBL Group, Inc. as the umbrella company.
