Re: Finance Docket No. 36447, Lake Providence Port Comm.— Feeder Line Application—Line of Delta South. R.R. Located in East Carroll and Madison Parishes, LA.

Dear Ms. Brown:

Lake Providence Port Commission ("LPPC"), in response to the Surface Transportation Board's ("STB") order permitting it to file an amended feeder line application in this docket, filed such amended application on January 3, 2023.

The STB decision granting LPPC the opportunity to file an amended feeder line application directed LPPC "to submit *all* evidence and argument in support of its" amended application "in accordance with the requirements specified in 49 C.F.R. § 1151.3, without incorporation by reference of its previous application or any other filings." *Lake Providence Port Comm.*— *Feeder Line Application*—*Line of Delta South. R.R. located in East Carroll and Madison Parishes*, *LA*. STB Finance Docket 36447 at 5 (Aug. 23, 2022)(emphasis added). The STB further explained that "LPPC has submitted numerous filings in this proceeding asserting various arguments on the merits throughout those filings. To ensure the fair and orderly resolution of LPPC's feeder line request, LPPC *must* include in its amended application *all of the arguments and evidence* on which it will rely." *Id*. at 7 (emphasis added).

LPPC has ignored that decision and is attempting yet again to move the target by filing on January 25, 2023, a "Motion to Supplement" its amended feeder line application. Moreover, the information provided in such motion is not new. It is a document from 2015 that was filed in the court proceeding before the Chancery Court in Delaware referenced by counsel for LPPC. However, an examination of the record of that court proceeding does not show any new documents having been filed in that proceeding since March 2022 (see attached).
