EGF's distribution fiscal year to date is comprised of 22% return of capital as of 3/31/2022

BIT's distribution fiscal year to date is comprised of 33% return of capital as of 3/31/2022

FRA's distribution fiscal year to date is comprised of 0% return of capital as of 3/31/2022

BGT's distribution fiscal year to date is comprised of 0% return of capital as of 3/31/2022

DSU's distribution fiscal year to date is comprised of 0% return of capital as of 3/31/2022

HYT's distribution fiscal year to date is comprised of 0% return of capital as of 3/31/2022

BTZ's distribution fiscal year to date is comprised of 0% return of capital as of 3/31/2022

BLW's distribution fiscal year to date is comprised of 0% return of capital as of 3/31/2022

⁷ BlackRock Income Trust, Inc. (NYSE:BKT) and BlackRock Income Trust, Inc. (NYSE:BBN) have adopted a Plan whereby the Funds will make fixed monthly distributions to common stockholders and will distribute all available investment income to its stockholders, consistent with their investment objective and as required by the Code. If sufficient investment income is not available on a monthly basis, the

Funds will distribute long-term capital gains and/or return capital to its stockholders in order to maintain a level distribution. The Fund is currently not relying on any exemptive relief from Section 19(b) of the 1940 Act. The Funds expects that distributions under the Plan will exceed current income and capital gains and therefore will likely include a return of capital. The Funds may make additional distributions from time to time, including additional capital gain distributions at the end of the taxable year, if required to meet requirements imposed by the Code and/or the 1940 Act. **No conclusions should be drawn about the Fund's investment performance from the amount of the Fund's distributions or from the terms of the Fund's Plan.**

BKT and BBN estimates that they have distributed more than its income and net realized capital gains in the current fiscal year; therefore, a portion of the distribution may be a return of capital. A return of capital may occur, for example, when some or all of a shareholder's investment is paid back to the shareholder. A return of capital distribution does not necessarily reflect BKT and BBN's investment performance and should not be confused with 'yield' or 'income'. When distributions exceed total return performance, the difference will reduce BKT or BBN's net asset value per share.

Although the character of income will not be determined until the end of the fund's fiscal year, BKT currently estimates that its distribution fiscal year to date is comprised of 99% net investment income and 20% return of capital.

Although the character of income will not be determined until the end of the fund's fiscal year, BBN currently estimates that its distribution fiscal year to date is comprised of 100% net investment income and 0% return of capital.

BKT and BBN will send its shareholders a Form 1099-DIV for the calendar year that will illustrate how its distributions should be reported for federal income tax purposes.
