The shares abstained will be counted in the calculation of the required majority.
- This supplemental form of proxy must be signed by you or your attorney duly authorized in writing or, in the case of a legal entity, must either be executed under seal or under the hand of a director or an attorney duly authorized to sign the same. If this supplemental form of proxy is signed by an attorney of the appointor, the power of attorney authorizing that attorney to sign, or other documents of authorization, must be notarized.
- 7. Where there are joint holders of any shares, any one of such persons may vote at the Annual General Meeting, either personally or by proxy, in respect of such shares as if he were solely entitled thereto. However, if more than one of such joint holders is present at the Annual General Meeting, either personally or by proxy, then the person present whose name stands first in the register of members in respect of such shares shall alone be entitled to vote in respect thereof.
- To be valid, for holders of H Shares, this supplemental form of proxy, together with the notarized power of attorney or other documents of authorization, must be delivered to the Company's H Share registrar, Computershare Hong Kong Investor Services Limited at 17M Floor, Hopewell Centre, 183 Queen's Road East, Wanchai, Hong Kong not less than 24 hours (excluding any part of a day that is a public holiday) before the time appointed for the Annual General Meeting (i.e. no later than 10:00 a.m. on 28 June 2022) or any adjournment thereof.
- This supplemental form of proxy is intended to be used for the supplemental resolution set out in the Supplemental Notice, and will not affect the validity of the form of proxy duly 9. completed by you in respect of the resolutions set out in the notice of Annual General Meeting dated 14 April 2022. If you have already validly appointed a proxy to attend and act on your behalf at the Annual General Meeting but have not completed and returned this supplemental form of proxy, your proxy will have the right to vote on the supplemental resolution set out in the Supplemental Notice at his/her discretion.
