The market closed the month of November in the positive after the ZSE All Share Index added 67.68 points (0.47%) to close at 14,577.46 points. Trading in the positive: **NMBZ HOLDINGS LIMITED** (NMB.zw) increased by \$3.2213 to \$29.9713, **DELTA CORPORATION LIMITED** (DLTA.zw) added \$3.0144 to \$235.2601 and **MASHONALAND HOLDINGS LIMITED** (MASH.zw) traded \$2.2000 higher at \$20.0000. **ECONET WIRELESS ZIMBABWE LIMITED** (ECO.zw) gained \$0.8710 to \$72.0210 whilst **FIRST CAPITAL BANK LIMITED** (FCA.zw) went up by \$0.7223 to \$10.2822.

Leading the shakers: **BRITISH AMERICAN TOBACCO ZIMBABWE LIMITED** (BAT.zw) shed \$50.3333 to \$3,049.6670, **AFRICAN DISTILLERS LIMITED** (AFDS.zw) lost \$2.5000 to \$257.5000 and **TANGANDA TEA COMPANY LIMITED** (TANG.zw) lost \$2.2174 to \$81.1159. **OK ZIMBABWE LIMITED** (OKZ.zw) traded \$1.7982 lower at \$28.1018 and **DAIRIBORD HOLDINGS LIMITED** (DZL.zw) was \$1.7011 down at \$39.9656.
