### The West Indian Tobacco Company Limited (WCO) - 13.01.2022

The Trinidad and Tobago Stock Exchange (TTSE) from WCO advising advising that in accordance with the Tobacco Control Regualtions 5 and 9 made pursuant to the Tobacco Control Act, the Company is required to implement changes to its packaging and cigarette dispensers

These changes require Graphic Helath Messages to be placed on the WCO's Dunhill, du Maurier, Brodway and Rothmans products and on its cigarette dispenser. The proposed changes commenced from January 13<sup>th</sup>, 2022 and will continue on a phased basis.

### Angostua Holdings Limited (AHL) - 11.01.2022

The TTSE received notice from AHL advising that the withdrawal of 457,269 AHL Ordinary shres from the TTSE effective Friday January 07th, 2022, was the final step in a transaction whereby 457,269 Ordinary Shares held by Trinidad Distillers Limited ("TDL") (a member of the Angostura Group) were voluntarily donated without valuable considerations, by TDL to AHL, pursuant to an agreement and in accordance with Section 46 of the Companies Act, Chap 81:01 ("the Act"). On January 07th, 2022 the said shares were cancelled pursuant to Section 50 of the Act.
