Following an audit of the cash flows during the locked box period, a final payment of \$11.2m was made to Evolution Mining and will be reflected within the net cash flows in the June 2022 quarter. This payment reflects a material build in working capital (mostly finished goods) during the locked box period, which has since largely been drawn down to normalised levels.
7. Inclusive of acquisition/integration costs, totalling approximately \$2.9M for the quarter (\$3.6M for year-to-date).
