Oil Pipeline Tariff Filing Special Permission Requested

Re: El Dorado Pipeline Company, LLC, Docket No. IS25-\_\_\_-000 Index-Based Ceiling and Rate Adjustments

Dear Acting Secretary Reese:

In accordance with the requirements of the Interstate Commerce Act ("ICA") and the Rules and Regulations of the Federal Energy Regulatory Commission ("FERC" or the "Commission"), in particular Section 342.3, 18 C.F.R. § 342.3 (2024) (Indexing), and in accordance with the Commission's Order Reinstating Index Level issued on September 17, 2024, El Dorado Pipeline Company, LLC ("El Dorado") submits for filing the following tariffs, to be effective November 1, 2024, on 14 days' notice:

FERC No. 2.16.0, canceling FERC No. 2.15.0 (Docket No. IS24-580-000) FERC No. 3.16.0, canceling FERC No. 3.15.0 (Docket No. IS24-580-000)

El Dorado is submitting FERC Nos. 2.16.0 and 3.16.0 to increase certain of its shipper rates for service. El Dorado is modifying certain of its service rates in accordance with the tariff rate indexing provisions of 18 C.F.R. § 342.3. The new tariff rates are equal to or less than the corresponding new ceiling levels calculated in accordance with 18 C.F.R. § 342.3(d) using the revised index multipliers going back to July 1, 2021, that are set forth in the 2024 Revised Index Order.<sup>2</sup> As shown on Schedule A, the current rates reflected in FERC Nos. 2.15.0 and 3.15.0 are below the newly recomputed ceiling levels set by the Commission and certain of those rates are accordingly increased to equal the recomputed ceiling levels, as reflected in proposed FERC Nos. 2.16.0 and 3.16.0.

In accordance with the requirements of 18 C.F.R. § 342.3(b) and the 2024 Revised Index Order, Schedule A sets forth the proposed new rates, the existing rates, the recomputed ceiling levels for each index year since July 1, 2021, and the recomputed ceiling level for the current index year.

Pursuant to 18 C.F.R. § 341.14 (Special Permission), El Dorado respectfully requests waiver under Section 6(3) of the ICA to file FERC Nos. 2.16.0 and 3.16.0 on less than thirty (30) days' notice, so that they may become effective on November 1, 2024. El Dorado respectfully submits that the 2024 Revised Index Order expressly indicated that pipelines may request special permission to waive the thirty (30) day notice requirement. El Dorado submits that good cause exists for granting a waiver because doing so will allow El Dorado to implement the revised index ceiling levels and rates, which have been calculated in accordance with the Commission's 2024 Revised Index Order, as soon as possible. El Dorado acknowledges that the above-referenced tariff is conditionally accepted, subject to refund, pending a thirty (30) day review period.
