## Good Corporate Governance on the Rise - 125 newly Accredited <u>Directors in 1 year</u>

August 22, 2024 – "This Government is committed to the reform of our Statutory Bodies and State-Owned Enterprises to ensure that they deliver their mandate in a professional, efficient, and effective manner." This was the declaration of Minister for Finance Hon. Dennis Cornwall as he addressed the twenty-five (25) newly accredited directors from eleven (11) State-owned Enterprises (SoEs), Statutory Bodies (SBs), and Ministries on Wednesday, August 21, 2024, at the Reception and Presentation of Certificate Ceremony for the Directors' Education and Accreditation Programme at the Coyaba Beach Resort.

Minister Cornwall stressed that with this training and accreditation, the NDC administration is set to make significant advances in delivering on its commitment to good governance, recapping its manifesto's position that government should be effective, responsive, efficient, honest, transparent, and accountable.

The ceremony celebrated the success of the twenty-five (25) directors who undertook the rigorous training and assessment of the programme facilitated by the Chartered Governance Institute of Canada (CGIC), in collaboration with the Eastern Caribbean Securities Exchange (ECSE) in March this year.

As of February 2023, one hundred and twenty-five (125) persons have been trained and qualified as accredited directors.

Delivering the keynote address, Deputy Chairperson of the Integrity Commission, Mr. Ronald Peters, pointed the accredited directors to the mandate of the Integrity Commission to, inter alia, "... ensure integrity in public life." He expressed confidence in the benefits of director training, asserting, "It is testimony to a strong sentiment throughout Grenada that there must be integrity in public life and in governance. I am confident that the directors are mindful of the gravity of the trust placed in them and that they will, especially with the benefit of the education they have now received, execute their charge with all integrity.".
