COLUMBIA, S.C. – The SCDC Inspector General released the arrest warrants today for four inmates in separate cases over the past month.

- Ibn Gadson, 28, attempted murder, assault with a concealed weapon and possession of contraband by a prisoner. These charges involve stabbing a correctional officer in the head with a homemade knife at Broad River CI.
- Robert Lee Myers Jr., 50, second-degree assault and battery. The charge involves severely injuring a fellow inmate during a fight at Evans CI.
- Rickylee Charles Eugene Smith, 36, five counts of third-degree sexual exploitation of a minor. The charges involve five child pornography videos found in Smith's Gmail account at Broad River Cl.
- Carnelius Joseph Floyd, 34, furnishing prisoners with contraband and possession of methamphetamines. The charges involve a contraband package including meth and a cellphone found in his assigned locker at Wateree River CI.

When a currently incarcerated person is charged with a crime, the inmate still must be served with a warrant and be afforded a bond hearing. For scheduling purposes, this happens at SCDC once a month. These are cases that came up for bond hearings in October. These are criminal charges in circuit court. They are different from disciplinary charges inmates might receive while incarcerated.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
