COLUMBIA, S.C. – The SCDC Inspector General released the arrest warrants today for a certified nursing assistant at Broad River Correctional Institution.

Jameelah Khadijah Fortune, 48, of Gaston, is charged with three counts of providing contraband to prisoners and three counts of criminal conspiracy. Her charges involve facilitating the contraband trade at Broad River CI during May and August of this year. She was fired.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
