

Overview of exchange trading

In February 2024, 45 353 trades totalling 86,30 billion UZS were concluded with securities of 78 issuers, which are in the exchange quotation list of the RSE «Toshkent», on trading floors. The objects of trades were 366,08 million securities.



In the daily context, the largest number of trades was concluded on February 15 - 3266 units; the smallest – on February 9 - 1156 units.

The largest volume of trades was recorded on February 12, when during the day the volume of trades amounted to more than 60,38 billion UZS. The average daily number of trades in February amounted to 2 159 trades; the average daily volume of trades amounted to 4,11 billion UZS. The average daily volume of trades on the "Main Board" of the Stock Market amounted to 516,96 million UZS. In the reporting month, 7 trades worth 73,24 billion UZS were concluded on the "Nego Board" site of the Stock Market.

157 trades totaling 2,20 million UZS were concluded on the "Main Board" of the Bond market.






45 189 trades with shares of 74 issuers totaling 10,86 billion UZS were recorded on the G1- "Main Board" section of the Stock Market.

The largest volume of trades with 577,00 thousand units of common shares of JSC «1-TEMIR BETON MAHSULOTLARI ZAVODI» /TBMZ/ in the amount of 3,00 billion UZS was concluded on the Stock market in section G1- "Main Board". The price was 5 200,00 UZS with a nominal value of 1 491,00 UZS.

In the T1 - Nego Board section, 7 trades with 6 issuers in the amount of 73,24 billion UZS were recorded. The largest volume of trades concluded in this section is accounted for securities of JSC "DORI-DARMON" /DORI/ in the amount of 60,24 billion UZS.






Trading volume on the Stock market by "Main Board" site, billion UZS



Top 10 stocks by the volume of trades, bln UZS

The largest volume of trades was recorded with common shares of JSC "1-TEMIR BETON MAHSULOTLARI ZAVODI" /TBMZ/ — 3,00 billion UZS. This is followed by JSCB "Universal Bank" /UNVB/ and JSC "O'zmetkombinat" /UZMK/, with common shares of which trades of 2,82 billion and 1,00 billion UZS were concluded, respectively. JSCB "Hamkorban" /HMKB/ - 190,53 million UZS and JSC "UzAuto Motors" /UZMT/ - 168,75 million UZS complete the Top 10 ordinary shares.



Top 10 stocks by the number of deals, units


The largest number of trades were concluded with shares JSCB "O'zsanoatqurilishbank" /SQBN/, amounting to 14 612 units per month. The second place in the Top 10 is occupied by shares of JSC "O'zbektelekom" /UZTL/c 2 287 trades. The Top 10 are completed by common shares of JSC "Qizilqumcement" /QZSM/ and preferred shares of JSCMB "IPOTEKA-BANK" /IPTBP/, with which 1 014 and 981 trades were recorded, respectively.



Industry structure

The industry leaders terms of transaction volume were securities related other to industries and securities of the energy industry. The volume of trades with securities of issuers of other industries amounted 63,50 billion UZS, which is 73,59% of the total exchange turnover. With securities of companies in the energy sector — 11,09 billion UZS, with securities of companies from the banking sector - 3,68 billion UZS. The smallest volume

was recorded with securities of issuers belonging to the Leasing industry, amounting to 441,92 thousand UZS or 0,001% of the total exchange turnover.

Number of trades in February 2024 by industry, units.




The largest number of trades made with securities of issuers of the banking sector -27 680 trades, 3 099 trades were made with securities of issuers of the industrial sector, and 2 973 trades were concluded with securities of issuers from the «Other» industry. The smallest number of trades was recorded with securities of issuers belonging to the sectors «Transport» 208 units and _ «Leasing» – 72 units.

During the reporting period, the total market capitalization of issuers of shares included in the stock exchange quotation list ranged from 161,15 trillion UZS to 168,93 trillion UZS.

The largest indicator of market capitalization fall on February 14 – 168,93 trillion UZS. The lowest value of the market capitalization was recorded on February 8, when the total capitalization of issuers was at the level of 161,15 trillion UZS.

As of 02.29.2024, the total market capitalization of issuers included in the exchange quotation list amounted to 167,51 trillion UZS. Compared to the beginning of the month, it increased by 2,30%. The number of issuers at the end of the period amounted to 102 units.



Exchange quotation list

As of February 1, 2024, there were 175 instruments of 117 issuers in the stock exchange quotation list.

During the reporting period, common shares of JSC "Ohangaronshifer" with the stock ticker OHSF were included in the stock quotation list. The Company is a commercial organization, the main purpose of which is to make a profit from financial and economic activities (production of asbestos cement products).



^{*} Due to the increase in the number of securities due to the issue of additional shares in the ratio of 1:1, the prices of ordinary and preferred shares of JSCB "Hamkorbank" were adjusted in relation to 1/2.

Comparing the closing price of shares at the beginning of February this year with the closing price on February 29, the price of securities of 3 issuers rose among the most traded shares. The most significant price increase was shown by the ordinary shares of JSICB "Ipak Yo'li" /IPKY/ - ▲ 66,67%. Also, the share prices of JSC "Qizilqumcement" /QZSM/ and JSCB "O'zsanoatqurilishbank" /SQBN/ increased by ▲ 3,81% and ▲ 2,80%, respectively.

A slight decline in prices was observed for securities of 4 issuers in the range from ▼0,29% to ▼5,65%, while the share prices of JSC "O'zmetkombinat" /UZMK/ fell by ▼8,70%.

It is worth noting that due to the additional issue of shares of JSCB «Hamkorbank" in proportion to the number and type of shares held by shareholders with a ratio of 1:1, on February 15, the share price was adjusted in a ratio of 1/2 (common shares 61,00/2=30,50 UZS; preferred shares: 58,79/2=29,40 UZS).




Overview of trading on OTC

In the period under review, 5 080 trades with 84,70 million securities of 55 issuers totaling 37,19 billion UZS were recorded on the non-listed trading platforms of RSE "Toshkent".

In the daily context, the largest number of trades was concluded on February 15 - 348 units; the smallest – on February 14 - 162 units. The largest volume of trades was recorded on February 23, when during the day the volume of trades amounted to more than 30,10 billion UZS.

The average daily number of trades in February amounted to 242 trades; the average daily volume of trades amounted to 1,77 billion UZS. The average daily volume of trades on the non-listed trading platform "Main Board" of the "SME Stock" market amounted to 15,86 million UZS. In February 2024, 5 trades worth 36,85 billion UZS were concluded on the "Nego Board" site of the "SME Stock" market. No trades were concluded on the non-listed trading platform "Main Board" of the "SME Bond" market during the reporting period.






Overview of OTC market





The largest number of trades was concluded with shares of JSC "Uzsanoateksport" /A056290/, amounting to 1 315 units per month. With 601 trades, shares of JSC "Uzparta'minot" /UZPT/ occupy the second place in the Top 5. The Top 5 ordinary shares of JSC "Hamroh invest" / A043500/ are closed, with which 206 trades were recorded.

The largest volume of trades was recorded with common shares of JSC "TOSHKENTVINO KOMBINATI" /A028090/ — 163,63 million UZS. This is followed by JSC "YO'LREFTRANS" /A051820/ and JSC "Uzikkilamchiranglimetall" /UVCM/, with common shares of which trades were concluded in the amount of 28,22 million and 24,68 million UZS, respectively.
