Re: CDL Exemption

Daimler Truck North America LLC is respectfully submitting this request for an exemption of the CDL requirements per §381.310 for a software engineer who holds a valid German CDL and requires the ability to legally test drive various DTNA vehicles on public roads while working here in the U.S. This individual plays a crucial role in directing company resources in developing and testing of thermal management functions for electric trucks globally.

- (c1) Andreas Munch, a software engineer specializing in the common powertrain controller for thermal management functions, is seeking an exemption to legally test drive various DTNA vehicles on public roads while working in the U.S. Mr. Munch holds a German CDL and requires this exemption due to his critical role in developing software and thermal management systems for electric trucks.

Mr. Munch is responsible for developing and optimizing the software that controls and manages the thermal systems of the vehicle's powertrain. He will need to conduct engineering test drives to validate the thermal management systems in our electric trucks. These validations must be performed over long driving cycles that encompass mixed road gradients, varying eAxle and battery loads, and temperatures to ensure optimal vehicle performance and safety. Testing on public roads allows Mr. Munch to gather valuable insights into real-world traffic scenarios, aligning software applications with actual driver experiences and maintaining high standards of quality and efficiency. Effective thermal management is essential for regulating engine and component temperatures, as well as providing appropriate cabin

heating and cooling, ensuring both operational efficiency and occupant comfort. To ensure safety during these test drives, Mr. Munch will always be accompanied by a U.S. state DMV-issued CDL holder who is familiar with the designated test routes. Mr. Munch is unable to obtain a U.S. CDL due to his lack of residency and is requesting for an exemption for the maximum allowable duration of five years.

This exemption is imperative to meet our future vehicle development and electric truck launch goals.

- (c2) We are asking that FMCSA grant an exemption for this driver from the following sections of 49 CFR for the maximum allowable duration of five years:
 - 49 CFR 383.23 CDL Requirements
- (c3) The exemption is requested for this driver only. The vehicles driven would be various vehicles from the DTNA fleet.
- (c4) We believe granting this exemption would have no impact on safety of U.S. roadways.
- (c5) We believe that the requirements for obtaining a German CDL guarantee a level of safety equivalent to or surpassing that of a U.S. state DMV-issued CDL. Furthermore, Mr. Munch is an experienced driver who is familiar with the operation of commercial motor vehicles. Finally, to further ensure safety, Mr. Munch will always be accompanied by a U.S. state DMV-issued CDL holder that is well-acquainted with the designated routes to be traveled in case of unforeseen circumstance.
- (c6) If this exemption is not granted, we believe that the successful development and launch of future electric trucks and advanced safety systems could be hindered. This individual plays a crucial role in developing and implementing software solutions that optimize the thermal management of a vehicle's powertrain system. It is essential for Mr. Munch to legally drive DTNA vehicles on U.S. roads to gain a comprehensive understanding of product requirements for these systems in real-world environments within the U.S. market.
