Re: Request for Approval of Amendments to Ohio Administrative Code (OAC) Rule 3745-18-82(F) into Ohio's State Implementation Plan (SIP)

Dear Ms. Shore:

On December 28, 1979, Ohio EPA promulgated rules in Ohio Administrative Code (OAC) Chapter 3745-18 for the control of sulfur dioxide (SO2) emissions from fuel burning equipment. Included in this rulemaking were regulations for SO2 emissions from Greif Packaging, LLC (OEPA premise number 1576000431) in paragraph (F) of OAC rule 3745-18-82. Ohio EPA is now submitting amended OAC rule 3745-18-82 to remove the site specific requirements in paragraph (F) from Ohio's SIP.

OAC 3745-18-82(F) formerly regulated fuel burning sources at the Greif Packaging, LLC (Greif) paperboard mill at 9420 Warmington Rd. SW in Massillon, Ohio. In 1979, when OAC rule 3745-18-82 was originally promulgated, Greif operated six boilers at their facility, emission units (EU) B001 to B006. Boilers B001 to B004 operated solely on natural gas, while B005 and B006 operated on natural gas with the capability to burn #2 or #6 fuel oil as a backup. Because boilers B005 and B006 had the ability to also burn fuel oil, Ohio EPA established facility specific regulations in OAC rule 3745-18-82(F). Ohio EPA did not develop emission limits for any other EUs at the facility because they burned solely natural gas and were therefore exempt from the requirements of OAC rule 3745-18-82.

U.S. EPA did not agree with Ohio's established emission limits in OAC rule 3745-18-82(F) and established a federal implementation plan (FIP). The FIP included an alternate SO2 emission limit for fuel burning equipment at Greif (40 CFR 52.1881(a)(27)(v)).

On January 23, 2006, Ohio EPA made amendments to our rules in OAC Chapter 3745-18 to address the FIP and bring Ohio's rules in line with the FIP.

Subsequently, boilers B005 and B006 were permanently shut down as of January 30, 2009, and August 4, 2009, respectively. There are no longer any boilers at this facility that can burn fuel oil or are equipped to burn any fuel other than natural gas. The burning of natural gas in fuel burning equipment is exempt from the requirements of OAC rule 3745-18-82 under OAC rule 3745-18-06(A). Therefore, as of 2009, there are no longer any boilers, and thereby any EUs at the facility subject to OAC rule 3745-18-82(F), and any new source (boiler) would have to undergo new

permitting to show compliance with the more stringent 2010 1-hour SO2 national ambient air quality standard.

On July 12, 2017, Greif began operation of a natural gas flare (P004) as a control device for emissions from an industrial wastewater pre-treatment anaerobic digester system. This unit emits sulfur dioxide but is not fuel burning equipment and would not be subject to the requirements in OAC rule 3745-18-82(F). Rather, P004 is subject to the SO2 requirements for process equipment in OAC rule 3745-18-82(A)(3). The existence of the language for fuel burning equipment in OAC rule 3745-18-82(F) is causing confusion concerning the rule under which P004 should be regulated.

Ohio EPA is removing the emission limits for Greif contained in OAC rule 3745-18-82(F) due to an absence of permitted sources and to prevent confusion over the regulation of non-fuel burning process equipment at the facility.

This letter should meet the requirements in 40 CFR Part 51, Appendix V, Section 2.1(a): a "formal letter of submittal from the Governor or his designee, requesting EPA approval of the plan or revision."

The following documents are attached for your consideration per the requirements of 40 CFR Part 51, Appendix V:

Article One addresses the following two requirements:

40 CFR Part 51, Appendix V, Section 2.1(b)

Evidence that the State has adopted the plan in the State code or body of regulations; or issued the permit, order, consent agreement (hereafter "document") in final form. That evidence shall include the date of adoption or final issuance as well as the effective date of the plan, if different from the adoption/issuance date.

40 CFR Part 51, Appendix V, Section 2.1(d)

A copy of the actual regulation, or document submitted for approval and incorporation by reference into the plan, including indication of the changes made to the existing approved plan, where applicable. The submittal shall be a copy of the official State regulation /document signed, stamped, and dated by the appropriate State official indicating that it is fully enforceable by the State. The effective date of the regulation/document shall, whenever possible, be indicated in the document itself.

Certified copies of the rule, in redline and strikeout, are being submitted for approval and incorporation by reference into the plan. The copy is included as evidence that the State has adopted the body of regulations in final form. This submittal includes copies of the official State regulation signed, stamped, and dated by the appropriate State official indicating that it is fully enforceable by the State. The effective date of the regulation is indicated in the document itself. Please consider that Ohio has an electronic rule filing system, and all certifications/signatures of regulations are done electronically.

Article Two addresses the following requirement:

Copies of the public notice of adoption and Director's Findings & Orders have been included as evidence of the date of adoption as well as the effective date of the regulations and evidence that public notice was given of the proposed changes consistent with procedures approved by EPA, including the date of publication of such notice.

Requirements of 40 CFR Part 51, Appendix V, Section 2.1(c):

Evidence that the State has the necessary legal authority under State law to adopt and implement the plan.

Ohio's legislature has given Ohio EPA authority under paragraphs (A) and (E) of Section 3704.03 of the Ohio Revised Code (ORC) to enact these rules. Copies of these sections of the ORC can be provided upon request.

Article Three addresses the following requirements:

40 CFR Part 51, Appendix V, Section 2.1(e)

Evidence that the State followed all of the procedural requirements of the State's laws and constitution in conducting and completing the adoption/issuance of the plan.

40 CFR Part 51, Appendix V, Section 2.1(f)

Evidence that public notice was given of the proposed change consistent with procedures approved by EPA, including the date of publication of such notice.

Ohio EPA has included a narrative and several attachments as evidence that the State followed all the procedural requirements of the State's laws and constitution in conducting and completing the adoption/issuance of the plan.

Article Four

40 CFR Part 51, Appendix V, Section 2.1(g)

Certification that public hearings(s) were held in accordance with the information provided in the public notice and the State's laws and constitution, if applicable.

A copy of the hearing summary from the public hearing including the public hearing speech, a copy of the attendance log, and the response to comments submitted during the hearing and associated public comment period has been provided as certification that a public hearing was held in accordance with the information provided in the public notice and the State's laws and constitution.

Article Five

40 CFR Part 51, Appendix V, Section 2.1(h)

Compilation of public comments and the State's response thereto.

Ohio EPA received no public comments on the proposed rule amendment during this rulemaking and subsequently generated no responses.

<u>Article Six</u> addresses the following requirement:

Application to Section 110(I) of the Clean Air Act

The amendments to this rule include removal of facility specific emission requirements that were formerly a part of Ohio's SIP. Article Six includes a discussion of the proposed change and a demonstration to show that this change would not interfere with any applicable requirement concerning attainment and reasonable further progress (RFP), or any other applicable requirement of the Clean Air Act.

Ohio EPA asks that the above-mentioned rule be accepted as a revision to Ohio's SIP as noted above.

Ohio EPA is submitting this SIP via U.S. EPA's State Planning Electronic Collaboration System (SPeCS).

3745-18-82 Stark county emission limits.

- (A) No owner or operator of a facility in Stark county, unless otherwise specified in this rule, shall cause or permit the emission of sulfur dioxide from any stack in excess of the following rates:
 - (1) For fossil fuel-fired steam generating units between ten and sixty MM Btu per hour total rated heat input capacity, the emission rate in pounds of sulfur dioxide per MM Btu actual heat input shall be calculated by the following equation:

$$EL = 18.48Qm^{-0.4886}$$

where:

Qm is the total rated capacity of heat input in MM Btu per hour, and

EL is the allowable emission rate in pounds of sulfur dioxide per MM Btu actual heat input.

- (2) For fossil fuel-fired steam generating units equal to or greater than sixty MM Btu per hour total rated heat input capacity, 2.50 pounds of sulfur dioxide per MM Btu actual heat input.
- (3) No owner or operator of any process equipment shall cause or permit the emission of sulfur dioxide from any stack in excess of 80.0 pounds of sulfur dioxide per ton of actual process weight input.
- (B) The "Canton Drop Forge" (OEPA premise number 1576000073) or any subsequent owner or operator of the "Canton Drop Forge, 4575 Southway Street Southwest, Canton, Ohio" shall not cause or permit the emission of sulfur dioxide from the following sources to exceed the amounts indicated and the units shall not exceed the operating limits indicated:
 - (1) [Reserved.]
 - (2) [Reserved.]
 - (3) For boiler numbers 2 and 3 (OEPA source numbers B002 and B003); a maximum of 2.5 pounds of sulfur dioxide per MM Btu actual heat input from each boiler.
 - (4) The total fuel oil consumption by all forge-shop furnaces shall not exceed seven hundred seventy-five gallons per hour, eighteen thousand six hundred gallons per day and six million seven hundred eighty-nine thousand gallons per year. [Forge-shop furnaces include emissions units P001 to P007, P009, P010, P016, and P041.]

(5) The sulfur content for any fuel oil used in the forge-shop furnaces shall not exceed 0.05 per cent by weight.

The Director's order of adoption was issued on April 6, 2023. These amended rules will become effective on **April 16, 2023.**

The Director's action in this matter is pursuant to the procedural requirements of Ohio Revised Code Chapter 119 and is based upon the record of the public hearing conducted by Ohio EPA on January 6, 2023, and comments received during the public comment period.

You are hereby notified that this action of the Director is final and may be appealed to the Environmental Review Appeals Commission pursuant to Section 3745.04 of the Ohio Revised Code. The appeal must be in writing and set forth the action complained of and the grounds upon which the appeal is based. The appeal must be filed with the Commission within thirty (30) days after notice of the Director's action. Article III

Evidence Ohio EPA Followed Rule Adoption Procedures

Evidence Ohio EPA Followed Rule Adoption Procedures

Ohio Revised Code (ORC) 119.03, Procedures for adoption, amendment, or rescission of rules; finding that fiscal analysis is incomplete or inaccurate, outlines the requirements Ohio EPA must follow during the rule-making process. A copy of ORC 119.03 can be provided upon request. Ohio EPA fully complied with the requirements of this law and has provided evidence on the major requirements below:

1. ORC 119.03(A): Reasonable public notice shall be given in the register of Ohio at least 30 days prior to the date set for a hearing.

Ohio's electronic rule filing system automatically posts public notices in the Register of Ohio when rules are proposed. A copy of the Public Hearing notice is included (Attachment A to Article III). The Public Hearing notice was placed in the Ohio Register on November 30, 2022. Ohio EPA held a public hearing on January 4, 2023 in Columbus, Ohio and virtually. This hearing was held 36 days after the notice was placed in the register. The ORC 119.03 requirements for public notice contents were met as evidenced by comparing the public notice and ORC 119.03 (A)(1)-(4).

2. ORC 119.03(B): The required materials must be filed with the secretary of state and the director of the legislative service commission (LSC).

Ohio's electronic filing system automatically generates a letter when all the required elements have been uploaded on the system and the package is proposed. This letter is included (Attachment B to Article III).

Ohio EPA also complied with all requirements for incorporated materials. In addition, the answers to questions nine and ten of the Rule Summary and Fiscal Analysis (RSFA) document is provided (Attachment C to Article III).

3. ORC 119.03(C): Conduct public hearings as advertised.

Ohio EPA conducted the public hearing on January 4, 2023 as identified in the Public Hearing notice. A copy of the hearing summary is provided in Article IV.

4. ORC 119.03(D): After the period of time when legislative review and invalidation may occur expires, the agency may issue an order adopting the rule.

The Joint Committee on Agency Rule Review (JCARR) oversees agency rulemaking in Ohio. A hearing was held with JCARR on January 30, 2023 where these rules were placed on the consent agenda as item 15 (Attachment D to Article III). No testimony, questions or invalidation of the rules occurred during this hearing. JCARR jurisdiction expired on February 3, 2023 as evidenced by the JCARR consent agenda.

Ohio EPA issued the order to adopt the rules on April 6, 2023 as evidenced by the Director's Findings & Orders and the Public Notice (both contained in Article II).

The Secretary of the State and Director of the LSC once again received a letter of notice (Attachment E to Article III).

5. ORC 119.03(E): Provide notice to public prior to effective date of rules.

Ohio EPA provided an update of the adoption of the rules through the Ohio EPA website, in the Register of Ohio, in the director's Weekly review, and through an email notice to all interested parties on April 6, 2023. A copy of these notifications can be provided upon request.

ORC 121.39, Provisions applicable to proposed legislation or administrative rules concerning environmental protection, imposes further requirements for interested party review specific to environmental rule adoption. Ohio EPA fully complied with the requirements of this law and has provided evidence on the major requirements below:

1. ORC 121.39(B): Legislation dealing with the environment must be accompanied by a statement identifying if it is necessary to comply with a federal requirement. It must also include information on the estimated cost of compliance.

The RSFA and Environmental Rule Adoption/Amendment Form (ERAF) documents are automatically generated questions that are part of the States electronic rule filing system (Attachment B to Article III). The questions are intended to address the items in ORC 121.39. As evidenced in Question 6 of the RSFA documents and item (C) of the ERAF for the rule, Ohio EPA stated the adoption of this rule, or a version as stringent as, is required by U.S. EPA. The RSFA documents also contain a section entitled Fiscal Analysis which addresses potential costs. Our responses met the requirements of this law as evidenced in the consent by JCARR who reviews these documents.

2. ORC 121.39(D): Prior to adopting any environmental rule, the agency must consult with interested parties, consider all documentation relevant to the need for the rule making, identify any need to adopt in order to maintain approval to administer a federal environmental law, and it must include an RSFA.

On September 8, 2022, Ohio EPA notified interested parties via e-mail of the draft rule language. A copy of the notification may be provided upon request. We provided a 30-day comment period closing October 11, 2022. The interested parties list included Ohio EPA, DAPC's general rule making list. A copy of the e-mail and interested party list will be provided upon request.

As evidenced in item (C) of the ERAF for this rule, Ohio EPA stated the adoption of this rule is required in order to maintain approval to administer a federal environmental law.

As evidenced in item (A) of the ERAF for this rule, Ohio EPA identified that it considered all documentation relevant to the need for the rule making and identified those documents in list form.

Public Notice Proposed Rulemaking Governing Amendments to Ohio Administrative Code (OAC) Rule 3745-18-82, "Stark County Emission Limits"

Notice is hereby given that the Director of Environmental Protection, under the authority of Section 3704.03(E) of the Ohio Revised Code and in accordance with Chapter 119, the Ohio EPA proposes to amend Ohio Administrative Code (OAC) rule 3745-18-82, "Stark County Emission Limits" and is now requesting public comments on the draft. This rule sets limits, testing and recordkeeping requirements for emissions of sulfur dioxide (SO2) from sources in Stark County, Ohio.

The purpose of this rule making is to amend paragraph (F) of the rule to remove facility specific information for the Greif Brothers Corporation for emissions units that have been permanently removed from the facility.

Pursuant to Section 121.39 of the Ohio Revised Code, Ohio EPA was required to consult with interested parties affected by the rules before the agency formally adopts them. On September 8, 2022, these rules went out for a 30-day review by interested parties. Please see the rule synopsis, available electronically at the web address below, for a complete summary of the proposed rule amendments.

Pursuant to Part D of Title I of the Clean Air Act, Ohio EPA is required to establish a state implementation plan (SIP) for the attainment and maintenance of the national ambient air quality standards (NAAQS). The above-mentioned rule is a part of Ohio's SIP for the attainment and maintenance of the 2010 SO2 NAAQS and the proposed amendments will be submitted to United States Environmental Protection Agency (U.S. EPA) as a modification of the SIP. The below hearing will also serve as the hearing for the SIP submittal.

Ohio EPA will be accepting comments on the proposed amended rule until January 4, 2023. A public hearing on this proposed rulemaking will be held to consider public comments in accordance with Section 119.03 of the Ohio Revised Code. Ohio EPA will be holding an in-person and virtual public hearing on the rules on **January 4, 2023 at 10:30 AM.** The in-person hearing will be at the same time and date and will be located at Ohio EPA, Suite 700, 50 W. Town Street, Columbus, Ohio 43215. During the hearing, the public may submit written comments on the record about the proposed rules if participating virtually and verbally if participating in person.

Registration for the in-person hearing is not required. Citizens intending to give testimony at the hearing should notify the Ohio EPA Public Interest Center, P.O. Prior registration will ensure that registrants are heard ahead of those individuals who register at the hearing. Oral testimony may be limited to five minutes, depending on the number of persons testifying. All interested persons are entitled to attend or be represented and to present oral and/or written comments concerning the proposed rulemaking.

Application to Section 110(I) of the Clean Air Act

Re: Demonstration under Section 110(I) of the Clean Air Act for Rule 3745-18-82(F) of the Ohio Administrative Code.

Dear Ms. Shore:

On December 28, 1979, Ohio EPA promulgated rules in Ohio Administrative Code (OAC) Chapter 3745-18 for the control of sulfur dioxide (SO_2) emissions from fuel burning equipment. Included in this rulemaking were regulations for SO_2 emissions from Greif Packaging, LLC (OEPA premise number 1576000431) in paragraph (F) of OAC rule 3745-18-82. This letter is intended to demonstrate that removing the requirements of OAC rule 3745-18-82(F) of Ohio's SIP would not cause a violation of Section 110(I) of the Clean Air Act.

Greif Packaging, LLC (Greif) operates a paperboard mill at 9420 Warmington Rd. SW in Massillon, Ohio. In 1979, when OAC rule 3745-18-82 was originally promulgated, Greif operated six boilers at their facility, emission units (EU) B001 to B006. Boilers B001 to B004 operated solely on natural gas, while B005 and B006 operated on natural gas with the capability to burn #2 or #6 fuel oil as a backup. Because boilers B005 and B006 had the ability to also burn fuel oil, Ohio EPA established facility specific regulations in OAC rule 3745-18-82(F). Ohio EPA did not develop emission limits for any other EUs at the facility because they burned solely natural gas and were therefore exempt from the requirements of OAC rule 3745-18-82.

As originally promulgated in 1979, Ohio EPA only established emission limits for boilers B005 and B006. The original language as adopted December 28, 1979, read:

"(F) The "Greif Board Brothers Corporation" (OEPA premise number 1576000431) or any subsequent owner or operator of the "Greif Board Brothers Corporation" facility located at 9420 Warmington, Southwest, Massillon, Ohio shall not cause or permit the emission of sulfur dioxide from boilers numbers 1 and 2 (OEPA source numbers B005 and B006) to exceed 1.8 pounds of sulfur dioxide per MM Btu actual heat input from each boiler and shall operate said boilers such that their combined average operating rate shall not exceed 53 MM Btu per hour for any calendar day."

USEPA did not agree with Ohio's established emission limits in OAC rule 3745-18-82(F) and established a federal implementation plan (FIP). The FIP included an alternate SO₂ emission limits for fuel burning equipment at Greif (40 CFR 52.1881(a)(27)(v)).

On January 23, 2006, Ohio EPA made amendments to our rules in OAC Chapter 3745-18 to address the FIP and bring Ohio's rules in line with the FIP. OAC rule 3745-18-82(F) was amended to reflect the FIP language as follows:

"(F) The "Greif Board Brothers Corporation" (OEPA premise number 1576000431) or any subsequent owner or operator of the "Greif Board Brothers Corporation" facility located at 9420 Warmington, Southwest, Massillon, Ohio shall not cause or permit the emission of sulfur dioxide from boilers numbers 1 and 2 (OEPA source numbers B005 and B006) to exceed 1.8 pounds of sulfur dioxide per MM Btu actual heat input from each boiler and shall operate said boilers such that their combined average operating rate shall not exceed 53 MM Btu per hour for any calendar day. any stack at this facility in excess of 0.50 pound of sulfur dioxide per MM Btu actual heat input."

Subsequently, boilers B005 and B006 were permanently shut down as of January 30, 2009, and August 4, 2009, respectively. There are no longer any boilers at this facility that can burn fuel oil or are equipped to burn any fuel other than natural gas. The burning of natural gas in fuel burning equipment is exempt from the requirements of OAC rule 3745-18-82 under OAC rule 3745-18-06(A). Therefore, as of 2009, there are no longer any boilers, and thereby any EUs at the facility subject to OAC rule 3745-18-82(F), and any new source (boiler) would have to undergo new permitting to show compliance with the more stringent 2010 1-hour SO_2 national ambient air quality standard.

On July 12, 2017, Greif began operation of a natural gas flare (P004) as a control device for emissions from an industrial wastewater pre-treatment anaerobic digester system. This unit emits sulfur dioxide but is not fuel burning equipment and would not be subject to the requirements in OAC rule 3745-18-82(F). Rather, P004 is subject to the SO_2 requirements for process equipment in OAC rule 3745-18-82(A)(3). The existence of the language for fuel burning equipment in OAC rule 3745-18-82(F) is causing confusion concerning the rule under which P004 should be regulated.

Ohio EPA plans to remove the emission limits for Greif Packaging LLC. contained in paragraph (F) from OAC rule 3745-18-82 due to an absence of permitted sources and to prevent confusion over the regulation of non-fuel burning process equipment at the facility.

Application to Section 110(I) of the Clean Air Act

As originally adopted in 1979, OAC rule 3745-18-82(F) was intended to address SO_2 emissions from two boilers (B005 and B006) at Greif in Massillon, Ohio. After reviewing Ohio's rule, USEPA established a FIP for fuel burning equipment at Greif in 40 CFR 52.1881(a)(27)(v). Ohio adopted the FIP for Greif in 2006 and as of 2009, with the permanent shut down of B005 and B006, no fuel-burning equipment remained at the facility capable of burning fuel other than natural gas. Additionally, no new fuel burning equipment could be installed at this facility without obtaining new permitting under the more stringent 2010 1-hour SO_2 standard.

In 2017, Greif began operation of process equipment with SO_2 emissions. This equipment is not fuel-burning equipment and is required to comply with the requirements for process equipment in OAC rule 3745-18-82(A)(3). The existence of the language for fuel burning equipment in OAC rule 3745-18-82(F) is a cause of confusion.

For these reasons, Ohio EPA believes that removing the Greif facility's SO₂ emission limits in OAC rule 3745-18-82(F) is appropriate and will not violate Section 110(I) of the Clean Air Act.
