SUBJECT: Proposal to Issue Draft Title V Outer Continental Shelf (OCS) Air Quality Permit to Park City Wind, LLC's proposed 804 MW New England 1 (NEW1) Wind Farm in Federal Waters

Dear Mr. Clayton:

EPA is initiating the public comment period for our proposal to issue a draft title V operating permit to Park City Wind, LLC for the operation of the OCS source offshore wind farm: New England Wind 1 Offshore Wind Farm (NEW1). At its nearest points, the wind farm will be approximately 15 nautical miles (NM) from the nearest Massachusetts shoreline.

Enclosed is the public notice for EPA's proposed action to approve the draft title V OCS operating permit. The public comment period begins December 2, 2024, and concludes January 16, 2025.
