



Gratuitous Services Agreement

1. This gratuitous services agreement is between RECIPIENT, the United States Department of Homeland Security, United States Citizenship and Immigration Service (hereafter USCIS, Government or Recipient and _____ (PROVIDER).

2. The duration of this gratuitous services agreement is for one year from _____ to _____, and may be renewed in increments of up to one year. The agreement cannot be extended except by the express, written, mutual consent of both parties.

Both parties can mutually consent to early termination of this agreement in writing. If the PROVIDER orally terminates the agreement early, the RECIPIENT will send confirmation of the termination in writing to PROVIDER's last known address _____ . This agreement can be unilaterally terminated by either party, with or without cause, with or without prior notification to the other party in writing. If the PROVIDER orally terminates the agreement early, the RECIPIENT will send confirmation of the termination in writing to PROVIDER's last known address _____ .

Both parties are prohibited from claiming or seeking damages from the other party because of any mutual or unilateral early termination of this agreement.

3. The terms of this agreement cannot be modified except by the express, written consent of both parties.

PROVIDER offers to provide the following gratuitous services to RECIPIENT:

- Appear and/or speak at USCIS or other DHS/USCIS events in person or virtually;
- Appear and/or speak at community-based, faith-based, or state or local government events in person or virtually;
- Organize and/or speak at an event related to USCIS mission;
- Other services not listed above, including: Click or tap here to enter text.

4. RECIPIENT agrees to accept PROVIDER's gratuitous services identified in Paragraph 3 above to the extent permitted by law.

5. PROVIDER agrees to provide the gratuitous services described in Paragraph 3 above with the full understanding that the Government cannot and will not compensate, provide any financial benefit to, or reimburse PROVIDER in any manner for providing those services.

6. PROVIDER agrees and declares that he/she has no expectation of receiving any compensation, financial benefit, or reimbursement of any kind from the Government for providing gratuitous services under this agreement.

7. PROVIDER agrees to make no claim for compensation, financial benefit, or reimbursement of any kind against the Government for gratuitous services provided under this agreement.

8. PROVIDER understands and agrees that it would be unlawful for RECIPIENT to accept PROVIDER services if PROVIDER had any expectation of any compensation, financial benefit, or reimbursement from the Government.

9. Both parties understand and agree that PROVIDER does not become an employee of USCIS or any other agency of the Government by providing services under this agreement. RECIPIENT declares that it will not replace or displace any federal employee because of this agreement.

10. RECIPIENT declares that it is not using this agreement in lieu of hiring a federal employee or contractor to perform the services described in Paragraph 3 above.

11. Both parties declare that this document constitutes the sole and complete agreement between them.
