Joseph Ali, J.D. is associate professor of international health, Johns Hopkins Bloomberg School of Public Health, and associate director for global programs, Johns Hopkins Berman Institute of Bioethics. He has expertise in international research ethics, global health ethics, and global digital health governance. For nearly 20 years, he has been involved with international collaborative bioethics and research ethics training initiatives that seek to advance scholarly, teaching and service capacities of individuals and institutions in lower-resourced countries. He is Co-PI of the NIH-funded Fogarty African Bioethics Post-Doctoral Fellowship Program and the Johns Hopkins University-Addis Ababa University Research Ethics Training Program; associate director of a Fogarty NIH bioethics program with faculty of Universiti Malaya in Kuala Lumpur, Malaysia; partner to Makerere University in Uganda on a doctoral training program in bioethics; and co-lead of the Wellcome-funded Oxford-Johns Hopkins Global Infectious Disease Ethics (GLIDE) collaborative. In the US, he has chaired and engaged in ethics and regulatory work groups for three pragmatic clinical research networks: the PCORI National Patient-Centered Outcomes Research Network (PCORnet), the NIH/VA/DOD Pain Management Collaboratory Coordinating Center, and the Pragmatic and Implementation Studies for the Management of Pain to Reduce Opioid Prescribing (PRISM) program, a component of the NIH HEAL Initiative. He teaches research ethics, global health ethics and digital health ethics at JHU; serves on the JHU School of Public Health Institutional Review Board (IRB); and is a member of the JHU School of Medicine Privacy Board. He's an elected fellow of The Hastings Center, an Associate Editor for the Journal of Empirical Research on Human Research Ethics, advisor to several bioethics training programs and centers, and has served on multiple World Health Organization (WHO) expert working groups.

Mark Barnes, J.D., is a partner at Ropes & Gray and represents major research universities, academic medical centers and other research institutions in matters related to human and animal research, stem cell and genomic research, research grants, research misconduct, and international research. Mark formerly served as the executive vice-president of St. Jude Children's Research Hospital, for which he established a vaccine research project in the Eastern Highlands of Zimbabwe, and later served at Harvard as the Senior Associate Provost and the University's Senior Research Officer. Sarah has served as a member of different research ethics committees and has been a lecturer in bioethics and law in the Pontifical Catholic University of Peru, Cayetano Heredia University, Clarkson University and FLACSO Argentina. Organization (PAHO) – the regional office for the Americas of the World Health Organization (WHO). Her main area of work and research is in research ethics.
