

Dear Mr. Scheppach:

I would like to invite the National Governors Association to share your recommendations and ideas on approaches for implementing the 8-hour ozone national ambient air quality standard (NAAQS) consistent with the February 27, 2001, Supreme Court decision.

As you may know, in July 1997, the Environmental Protection Agency (EPA) revised the ozone NAAQS by setting an 8-hour standard based on new health studies. The EPA set this standard to better protect Americans from ozone-related health problems, such as aggravating asthma and other respiratory ailments.

After lengthy litigation, the U.S. Supreme Court upheld the Clean Air Act provisions for setting national air quality standards. The Court also determined that a new ozone standard can be implemented, but said that the EPA must reconsider its implementation plan for moving from the pre-existing 1-hour standard to the revised standard.

Based on this decision, we are planning to move forward to develop a plan to implement the 8-hour ozone NAAQS in consultation with the stakeholders like you. During the period the U.S. Court of Appeals considers the remaining litigation issues, we believe that we have an opportunity for meaningful dialogue with you and others to develop an approach to implementation that is consistent with the Supreme Court ruling. Our Administrator, Christine Todd Whitman, has asked us to work with you to obtain your thoughts on how to implement the standard.

Some of the topics on which we hope to obtain your ideas are: geographic area classifications, timing regarding attainment dates and submissions for State Implementation Plans, rate of progress requirements, and credit for early voluntary control of emissions. You may have also been aware that a number of ideas had already emerged a few years ago during a Federal Advisory Committee Act (FACA) process on implementation of the revised air quality standards.
