Dear Honorable Leader:

The U.S. Environmental Protection Agency (EPA) is initiating consultation with federally recognized Indian Tribes to obtain input on the agency's proposed amendments to the Standards of Performance for new, modified, and reconstructed stationary combustion turbines and stationary gas turbines, also known as the New Source Performance Standards (NSPS) for stationary gas and combustion turbines, at 40 CFR Part 60 Subparts GG and KKKK. These proposed amendments reflect the Agency's review of available control technologies to limit emissions of criteria air pollutants.

In this rulemaking, the EPA is proposing that combustion controls combined with selective catalytic reduction post-combustion control technology is the best system of emission reduction to reduce nitrogen oxides (NOx), with limited exceptions. Based on this approach and new technical information, the EPA is proposing to lower NOx emission limits for most of these turbines. The EPA also is proposing provisions for these turbines that burn hydrogen to ensure that they meet the same NOx control levels as those burning natural gas or other non-gas fuels. The EPA also is proposing amendments to clarify the existing regulations. This NSPS has a consent decree deadline for signature of a final rule by November 12, 2025.

The proposed rule will publish in the *Federal Register* in the coming weeks, and the EPA will be accepting public comments for 90 days after the publication date in the *Federal Register*. We have enclosed a fact sheet regarding the proposed NSPS. The EPA's anticipated timeline for the consultation period is expected to extend through February 15, 2024. This consultation process will be conducted consistent with the EPA Policy on Consultation with Indian Tribes¹ and the Guidance for Discussing Tribal Treaty or Similar Rights.² The EPA invites you and/or your designated consultation representative(s) to participate in this process to discuss information related to the Review of New Source Performance Standards for Stationary Combustion Turbines and Stationary Gas Turbines, including treaty or similar rights, Indigenous knowledge, and sacred sites.

We request your input to assure that we develop the best rule possible. We endeavor to conduct our efforts with sensitivity to the needs and culture of your Tribe and with attention to the potential impact of our actions. I look forward to hearing from you on this important matter.
