Re: Request to revise the Ohio State Implementation Plan for the Carbon Monoxide and Ozone Air Quality Standards, and Related Emission Requirements Rules

Dear Mr. Skinner:

I am writing to formally request a revision to the Ohio State Implementation Plan (SIP) to incorporate minor changes and additional language recently made as a result of Ohio EPA's required five-year rule review program and comments received from interested parties regarding the rules contained in Chapter 3745-21 of the Ohio Administrative Code (OAC). The rules were adopted on October 25, 2002 and became effective on November 5, 2002. (OAC rule 3745-21-11 was a "no change rule" and did not affect the current SIP and does not require your review.) Due to the large reduction in the size of OAC rule 3745-21-04, mostly due to the removal of interim compliance dates, OAC rule 3745-21-04 had to be rescinded, and the rule re-proposed as new. OAC rule 3745-21-07 is still undergoing the review process, and a SIP revision request will be submitted under separate cover for this rule. The specific rules from OAC Chapter 3745-21 that now have updated language, clarifications, and additional language are listed below:

3745-21-01	Definitions.
3745-21-02	Ambient air quality standards and guidelines.
3745-21-03	Methods of ambient air quality measurement.
3745-21-04	Attainment dates and compliance time schedules.
3745-21-06	Classification of regions.
3745-21-08	Control of carbon monoxide emissions from stationary sources.
3745-21-09	Control of emissions of volatile organic compounds from stationary sources.
3745-21-10	Compliance test methods and procedures.
