PERMIT TO IMPORT AND EXPORT PROTECTED SPECIES¹ PARTS FOR SCIENTIFIC PURPOSES

I. Authorization

This permit is issued to Field Museum, 1400 S. Lake Shore Drive, Chicago, Illinois, (hereinafter "Permit Holder"), [Responsible Party: Kevin Feldheim, Ph.D], pursuant to the provisions of the Endangered Species Act of 1973 (ESA; 16 U.S.C. 1531 *et seq.*) and the regulations governing the taking, importing, and exporting of endangered and threatened species (50 CFR Parts 222-226).

II. Abstract

The objective of the research is to investigate the population genetics and basic breeding biology of three species of angelsharks.

III. Terms and Conditions

The activities authorized herein must occur by the means, in the areas, and for the purposes set forth in the permit application, and as limited by the Terms and Conditions specified in this permit, including attachments and appendices. Permit noncompliance constitutes a violation and is grounds for permit modification, suspension, or revocation, and for enforcement action.

A. Duration of Permit

- 1. Personnel listed in Condition C.1 of this permit (hereinafter "Researchers") may conduct activities authorized by this permit through December 31, 2027. This permit expires on the date indicated and is non-renewable. This permit may be extended by the Director, NMFS Office of Protected Resources or the Chief, Permits and Conservation Division (hereinafter "Permits Division"), pursuant to applicable regulations and the requirements of the ESA.
- 2. Researchers must immediately stop permitted activities and the Permit Holder must contact the Permits Division for written permission to resume if authorized numbers for import or export are exceeded. See Condition E.2 for reporting requirements.

¹ "Protected species" include species listed as threatened or endangered under the ESA, and marine mammals.



Number and Kinds of Protected Species, Locations and Permitted Activities B.

- 1. The table in Appendix A outlines the number of animals, by species, from which protected species parts may be imported or exported, and the locations and time periods in which these activities may occur.

- Biological samples³ may be obtained from samples would be from live capture 3. research activities, primarily in the Northeastern Atlantic (i.e., samples from other authorized persons or collections).
- 4. Biological samples obtained from sources in B.3 above may be exported and reimported.
- 5. Protected species parts imported under the authority of this permit must be taken in compliance with the ESA and any applicable foreign law. Importation of protected species parts is subject to the provisions of 50 CFR Part 14.
- The Permit Holder must comply with the following conditions for biological 6. samples acquired or possessed under authority of this permit.
 - The Permit Holder is ultimately responsible for compliance with this a. permit and applicable regulations related to the samples unless the samples are permanently transferred per Condition B.6.d.
 - Biological samples must be maintained according to accepted curatorial b. standards and must be labeled with a unique identifier (e.g., alphanumeric code) that is connected to on-site records with information identifying the:
 - i. Species and, where known, age and sex;
 - ii. Date of collection, acquisition, or import;
 - iii. Type of sample (e.g., blood, fin clips);
 - iv. Origin (i.e., where collected or imported from); and
 - Legal authorization for original sample collection or import. v.
 - c. For temporary transfers:
 - i. The Permit Holder may designate Authorized Recipients (ARs) for analysis and curation of samples related to the permit objectives.

² A take under the ESA means to harass, harm, pursue, hunt, shoot, wound, kill, trap, capture, or collect, or attempt to do so.

³ Biological samples include, but are not limited to: carcasses (whole or parts); and any tissues, fluids, or other specimens from live or dead protected species.

The Permit Holder must maintain a record of the transfer including the following:

- 1. Name and affiliation of the AR;
- 2. Address of the AR;
- 3. Types of samples sent (species, tissue type);
- 4. Type of analysis; and
- Whether samples will be consumed in analysis, returned to 5. the Permit Holder, curated, or destroyed.
- ii. The Permit Holder must provide a written copy of the AR designation and the permit per Condition D.3 when transferring samples to the AR (contact your permit analyst for an example letter).
- iii. Samples remain in the legal custody of the Permit Holder while in the possession of ARs. The Permit Holder remains responsible for the samples, including any reporting requirements.
- For permanent transfers: If the Permit Holder wishes to permanently d. transfer angelshark samples (i.e., relinquish custody), all subsequent recipients must maintain a copy of this permit to document the legal collection of the samples.
- This permit does not authorize the creation or use of protected species cell e. lines.
- f. Samples cannot be bought or sold. This does not apply to reimbursement associated with actual costs (e.g., shipment or transport costs).
- After meeting the permitted objectives, the Permit Holder may continue to g. possess and use (excluding export) biological samples acquired under this permit, including after permit expiration, without additional written authorization. The samples must be maintained as specified in the permit and a copy of the permit must be kept with the samples forever.

Qualifications, Responsibilities, and Designation of Personnel C.

1. At the discretion of the Permit Holder, the following Researchers may participate in the conduct of the permitted activities in accordance with their qualifications and the limitations specified herein:

- Principal Investigator Kevin Feldheim, Ph.D.; a.
- Co-Investigator(s) none listed; and b.
- Research Assistants –personnel identified by the Permit Holder or c. Principal Investigator and qualified to act pursuant to Conditions C.2, C.3, and C.4 of this permit.
- 2. Individuals conducting permitted activities must possess qualifications commensurate with their roles and responsibilities. The roles and responsibilities of personnel operating under this permit are as follows:
 - The Permit Holder is ultimately responsible for activities of individuals a. operating under the authority of this permit. Where the Permit Holder is an institution/facility, the Responsible Party is the person at the institution/facility who is responsible for the supervision of the Principal Investigator.
 - The Principal Investigator (PI) is the individual primarily responsible for b. the taking, import, export and related activities conducted under the permit. The PI must be on site during activities conducted under this permit unless a Co-Investigator named in Condition C.1 is present to act in place of the PI.
 - Co-Investigators (CIs) are individuals who are qualified to conduct c. activities authorized by the permit, for the objectives described in the application, without the on-site supervision of the PI. CIs assume the role and responsibility of the PI in the PI's absence.
 - d. Research Assistants (RAs) are individuals who work under the direct and on-site supervision of the PI or a CI. RAs cannot conduct permitted activities in the absence of the PI or a CI.
- 3. Persons who require state or Federal licenses to conduct activities authorized under the permit must be duly licensed when undertaking such activities.
- 4. The Permit Holder cannot require or receive direct or indirect compensation from a person approved to act as PI, CI, or RA under this permit in return for requesting such approval from the Permits Division.
- 5. The Permit Holder or PI may add CIs by submitting a request to the Chief, Permits Division that includes a description of the individual's qualifications to conduct and oversee the activities authorized under this permit. If a CI will only be responsible for a subset of permitted activities, the request must also specify the activities for which they would provide oversight.

- 6. Where the Permit Holder is an institution, the Responsible Party may request a change of PI by submitting a request to the Chief, Permits Division that includes a description of the individual's qualifications to conduct and oversee the activities authorized under this permit.
- 7. Submit requests to add CIs or change the PI by one of the following:
 - a. The APPS online system at https://apps.nmfs.noaa.gov;
 - b. An email attachment to the permit analysts for this permit; or
 - c. A hard copy mailed to the Chief, Permits Division, Office of Protected Resources, NMFS, 1315 East-West Highway, Room 13705, Silver Spring, MD 20910; phone (301)427-8401.

D. Possession of Permit

- 1. This permit cannot be transferred or assigned to any other person.
- 2. The Permit Holder and persons operating under the authority of this permit must possess a copy of this permit when:
 - a. Engaged in a permitted activity;
 - b. A protected species part is in transit incidental to a permitted activity; and
 - c. A protected species part imported or exported under the permit is in the possession of such persons.
- 3. A duplicate copy of this permit must accompany or be attached to the container, package, enclosure, or other means of containment in which a protected species part is placed for purposes of storage or transit.

E. Reports

- 1. The Permit Holder must submit annual, final, and incident reports containing the information and in the format specified by the Permits Division.
 - a. Reports must be submitted to the Permits Division by one of the following:
 - i. The APPS online system at https://apps.nmfs.noaa.gov;
 - ii. An email attachment to the permit analysts for this permit; or

iii. A hard copy mailed to the Chief, Permits Division.

- b. You must contact your permit analysts for a reporting form if you do not submit reports through the online system.
- 2. Incident reports: must be submitted within two weeks of exceeding authorized import or export, as specified in Condition A.2.
 - a. The incident report must include a complete description of the events and identification of steps that will be taken to reduce the potential for exceeding authorized import or export.
 - b. In addition to the written report, the Permit Holder must contact the Permits Division by phone (301-427-8401) as soon as possible, but no later than within two business days of the incident.
 - c. The Permits Division may grant authorization to resume permitted activities based on review of the incident report and in consideration of the Terms and Conditions of this permit.
- 3. Annual reports describing activities conducted during the previous permit year (from January 1 to December 31 of the following year) must:
 - a. Be submitted by March 31 each year the permit is valid; and
 - b. Include a tabular and narrative accounting of activities (Appendix D).
- 4. A joint annual/final report including a discussion of whether the objectives were achieved must be submitted by (March 31, 2028), or, if the research concludes prior to permit expiration, within 90 days of completion of the research.
- 5. Research results must be published or otherwise made available to the scientific community in a reasonable period of time. Copies of technical reports, conference abstracts, papers, or publications resulting from permitted research must be submitted the Permits Division upon request.
- F. <u>Coordination</u>: To the maximum extent practical, the Permit Holder must coordinate permitted activities with activities of other Permit Holders conducting the same or similar studies on the same species.

G. Observers and Inspections

- 1. NMFS may review activities conducted under this permit. At the request of NMFS, the Permit Holder must cooperate with any such review by:
 - a. Allowing any employee of NOAA or other person designated by the Director, NMFS Office of Protected Resources to observe permitted activities; and

b. Providing all documents or other information relating to the permitted activities.

Η. Modification, Suspension, and Revocation

- 1. Permits are subject to suspension, revocation, modification, and denial in accordance with the provisions of Subpart D [Permit Sanctions and Denials] of 15 CFR Part 904.
- 2. The Director, NMFS Office of Protected Resources may modify, suspend, or revoke this permit in whole or in part:
 - In order to make the permit consistent with any change made after the date a. of permit issuance with respect to applicable regulation prescribed under Section 4 of the ESA:
 - b. In a case in which a violation of the terms and conditions of the permit is found;
 - In response to a written request⁴ from the Permit Holder; c.
 - If NMFS determines that the application or other information pertaining to d. the permitted activities (including, but not limited to, reports pursuant to Section E of this permit and information provided to NOAA personnel pursuant to Section G of this permit) includes false information; and
 - If NMFS determines that the authorized activities will operate to the e. disadvantage of threatened or endangered species or are otherwise no longer consistent with the purposes and policy in Section 2 of the ESA.
- 3. Issuance of this permit does not guarantee or imply that NMFS will issue or approve subsequent permits or modifications for the same or similar activities, including those of a continuing nature, requested by the Permit Holder.

I. **Penalties and Permit Sanctions**

1. A person who violates a provision of this permit, the ESA, or the regulations at 50 CFR Parts 222-226 is subject to civil and criminal penalties, permit sanctions, and forfeiture as authorized under the ESA and 15 CFR Part 904.

⁴ The Permit Holder may request changes to the permit related to: the objectives or purposes; the species or number of animals, and the location, time, or manner of taking/collecting, importing and exporting protected species. Such requests must be submitted in writing to the Chief, Permits Division in the format specified in the application instructions.

- 2. The NMFS Office of Protected Resources shall be the sole arbiter of whether a given activity is within the scope and bounds of the authorization granted in this permit.
 - a. The Permit Holder must contact the Permits Division for verification before conducting the activity if they are unsure whether an activity is within the scope of the permit.
 - b. Failure to verify, where the NMFS Office of Protected Resources subsequently determines that an activity was outside the scope of the permit, may be used as evidence of a violation of the permit, the ESA, and applicable regulations in any enforcement actions.

J. Acceptance of Permit

- 1. In signing this permit, the Permit Holder:
 - a. Agrees to abide by all terms and conditions set forth in the permit, all restrictions and relevant regulations under 50 CFR Part 222-226, and all restrictions and requirements under the ESA;
 - b. Acknowledges that the authority to conduct certain activities specified in the permit is conditional and subject to authorization by the NMFS Office Director; and
 - c. Acknowledges that this permit does not relieve the Permit Holder of the responsibility to obtain any other permits, or comply with any other Federal, State, local, or international laws or regulations.

Statement of Activities

The Angelshark (Squatina squatina) belongs to one of the worlds most threatened familes of elasmobranchs (Family Squatinidae, Dulvy et al 2014) with targeted conservation efforts aiming to restore and safeguard its depleted populations throughout the natural range (Barker et al. 2016, Gordon et al. 2017). Important questions remain about the population structure and ecology of angel sharks worldwide that need to be answered to establish population baselines, monitor population trajectories over time, and develop effective management practices.

Among very few other places throughout its distribution range in the Northeast Atlantic and the Mediterranean Sea, the Canary Islands have been identified as a unique hotspot where the Angelshark is encountered on a regular basis throughout the year (Barker et al. 2016, Meyers et al., 2017; Gordon et al. 2017). Despite increased research efforts aiming at better understanding the ecology and biology of this species, aspects of the connectivity, dispersal patterns and reproductive behavior of this shark, classified as Critically Endangered (CR) by the International Union for Conservation of Nature (IUCN) Red List of Threatened Species (Morey et al. 2019) remain poorly understood. The cryptic nature of angel sharks and the limited knowledge about the distribution patterns have, thus far, hindered a comprehensive study of its reproductive behavior, which is essential for the implementation of appropriate conservation strategies. In the Canary Islands Angelsharks are distributed along the entire coastline, however, the inter-island distribution patterns of Angelsharks significantly decreases from the easternmost towards the westernmost islands (Meyers et al., 2017). This east to west gradient in the composition and abundance of marine species across the archipelago is also common for other coastal fishes (Tuya et al., 2004) and could be attributed to the large-scale oceanographic variability linked with the proximity of the Canary Islands to the African coast and its seasonal upwellings (Davenport, Never, Helmke, Pérez-Moreno, & Llinas, 2002). Moreover, abyssal barriers between some islands within the Archipelago, may also constrain connectivity between islands for fauna of limited pelagic dispersal (Brito et al., 2002) and could have caused separate Angelshark populations with restricted connectivity within the Canary Islands (Meyers et al. 2017).

At a finer geographical scale, the movement of Angelsharks into shallower waters in the Canary Islands has also been documented during parturition and juvenile development (Meyers et al. 2017, Escanez et al., Jimenez et al., 2020). Migrations into deeper and perhaps offshore areas are suspected in adult life stages, particular in male sharks who seem to return to shallow coastal areas during the mating season. Female Angelsharks on the other hand, have been observed in coastal areas both during the mating season and giving birth, mostly in the warmer summer months. While there have been nursery areas identified in the Canary Islands (Meyers, Escanez, Jimenez), it also critical to understand if these sharks show philopatry to a specific nursery area, for example if female sharks will return to same areas to give birth over multiple years and if juvenile sharks will return to their birth sites for reproduction once they have reached maturity. Reproductive philopatry is known to occur in other elasmobranch species for example lemon sharks Negaprion brevirostris (Feldheim et al. 2004), sandbar sharks Carcharhinus plumbeus (Portnoy et al. 2010) and Smalltooth Sawfish Pristis pectinata (Smith et al., 2021). Hence,



understanding these mating and dispersal behaviors will shed light on the gene flow and provide a sound basis for effective management practices at the appropriate spatial scale.

Here we aim to (1) examine the connectivity and genetic differences between Angelshark populations in the Canary Islands; (2) to reconstruct parental genotypes from juvenile Angelsharks sampled within the largest nursery, in order to identify if females or males exhibit site fidelity to this nursery area (3) to discuss the implications of our findings for management and conservation strategies in the Canary Islands; and finally (4) examine angelshark population genetics on a broader scale to include samples from the Mediterranean Sea and the United Kingdom.
