Discussed worker protection measures for EtO. OSHA provided EPA with an overview of OSHA EtO Standard 1910.1047.

#### February 15, 2024

Discussed worker protection measures for EtO. OSHA provided EPA with information on OSHA EtO Standard 1910.1047, as well as joint EPA-OSHA guidance on PRN 2012-1 Material Safety Data Sheets as Pesticide Labeling.

#### March 26, 2024

Discussed inter-Agency jurisdiction, EPA preemption, and the implications for implementation of worker protections measures in the upcoming EtO Interim Decision.

#### May 9, 2024

Discussed EPA's preemption and the implications for implementation of worker protections measures in the upcoming EtO Interim Decision.

#### August 1, 2024

Discussed OSHA's Respiratory Protection Standard 1910.134, and possible language for EtO product labels.

EPA presented OSHA with a detailed presentation of the mitigation to be included in the upcoming EtO Interim Decision (ID).
