Further, the industry's own ANSI-accredited G300 standard mandates carbon monoxide sensors and automatic shutoffs for portable generators - a standard to which nearly 85% of available product already conforms!

The list of products that make life better - but that can also be dangerous (or even deadly) due to misuse and abuse - is lengthy and includes such common things as automobiles, toasters, kitchen knives, and curling irons. There is no way to 100% regulate away every potential danger from misuse. The good news is the industry's G300 standard already prevents over 98% of CO-related incidents from misuse related to portable generators.
