## **BRONX MEN INDICTED FOR SHOOTING BOYS IN A MCDONALD'S "1300" Crew Members Targeted Victims—Ages 12 and 13—Over Disrespect for Crew**

Bronx District Attorney Darcel D. Clark today announced that two men have been indicted for Attempted Murder and related charges for shooting and wounding two boys as they ate in an Allerton McDonald's restaurant.

District Attorney Clark said "The defendants allegedly sought out the two children and fired at them multiple times in the middle of a McDonald's supposedly because the boys disrespected their crew. This brazen, senseless violence put the restaurant workers and other customers at risk. Fortunately, the boys survived the shooting, but their lives have been changed."

District Attorney Clark said Waynol Recio, 19, of Secor Avenue, and Dreshawn Lucas, 21, of Beach Avenue, were charged with two counts of Attempted Murder, first-degree Criminal Use of a Firearm, four counts of Attempted Assault in the first degree, two counts of second-degree Assault, two counts of Attempted Assault in the second-degree, two counts of second-degree Criminal Possession of a Weapon, Criminal Possession of a Firearm, fourth-degree Criminal Possession of a Weapon, and two counts of Endangering the Welfare of a Child. Recio was arraigned yesterday before Bronx Supreme Court Justice Seth Steed. The defendant was remanded and is due back in court on December 13, 2024. Lucas will be arraigned at a later date.

According to the investigation, on July 6, 2024, at approximately 10:00 p.m., the victims, ages 12 and 13, were eating at the McDonalds on White Plains Road near Mace Avenue in the Allerton neighborhood. Recio allegedly entered the restaurant wearing a mask after being driven there by Lucas. Recio allegedly opened fire, striking the 12-year-old boy once in the leg, once in the back, and once in the buttocks. The 13-year-old was shot once in the leg. The defendants are allegedly members of the "1300" street crew and allegedly intended to shoot the two children after believing the victims disrespected the crew.

The case is being prosecuted by Assistant District Attorney Charlayne White of the Violent Criminal Enterprise Bureau and Newton Mendys, Chief of the Violent Enterprise Bureau, under
