On August 26, 2024, at approximately 0900 hours, I, Deputy Briana Deibler, responded to the Grant Street Magnetometer for a male who entered the courthouse with a red metal walking cane with two daggers concealed inside. Allegheny County building security officers, Charlie Wiles #146 and Dave Bauer #159, ran the male identified as Stephan Ratulowski's belongings through the magnetometer which indicated Exhibit 1: 4 inch dagger concealed inside a red metal cane and Exhibit 2: 4 inch fork dagger concealed inside a red metal cane. Security officers questioned Ratulowski concerning the image indicated by the magnetometer and he denied having knowledge of the weapon. Several other deputies and myself arrived on scene at this time. The weapon was secured and Ratulowski was taken into custody incident to arrest.
