NARRATIVE: Driver 1 was southbound on ND Highway 20 and Driver 2 was eastbound on Military Road. Driver 2 was initially stopped at a stop sign waiting for southbound traffic to clear prior to negotiating a left turn to travel north on ND Highway 20. An uninvolved motor vehicle made a legal right turn onto Military Road which obstructed the view of Driver 2 as he attempted his turn to travel north. Driver 1, who was directly behind the vehicle making a right turn collided with Driver 2 at right angle. Driver 1 was transported by ambulance to CHI Saint Alexius Hospital in Devils Lake for injuries sustained in the crash. Driver 2 and Passenger 1 of Vehicle 2 received minor injuries and were treated and released on-scene. All juvenile passengers were uninjured in the crash. The names of the adult parties involved will be released at a later date and time. The names of the juveniles will not be released.
