RESOLUTION OF THE WATER REPLENISHMENT DISTRICT OF SOUTHERN CALIFORNIA ("WRD") AUTHORIZING THE GENERAL MANAGER TO EXECUTE IDENTIFIED DOCUMENTS REQUIRED TO PROCESS PLANNING AND DEVELOPMENT RELATED MATTERS WITH THE CITY OF LAKEWOOD, COUNTY OF LOS ANGELES, FAA, AND SOUTHERN CALIFORNIA EDISON RELATED TO THE REAL PROPERTY LOCATED AT 3919 PARAMOUNT BOULEVARD

RECITALS

- A. WHEREAS, WRD currently owns certain real property consisting of approximately 2.21 acres generally located at 3919 Paramount Blvd in the City of Lakewood, County of Los Angeles, State of California, and currently more particularly identified by Los Angeles County Assessor's Parcel No. 7149-004-009 (the "Real Property"); and
- B. WHEREAS, WRD identified the Real Property as a potential site for varying uses by the agency, including but not limited to off-site storage for office, testing and sampling equipment, miscellaneous supplies, and fleet parking; and
- C. WHEREAS, in furtherance of the goal of developing the site for the desired usage, staff has commenced efforts to separate the parcel into two separate parcels, one for current development and construction of a pre-engineered building/warehouse and the other for potential future development and/or disposition ("Project"); and
- D. WHEREAS, in order to process the planning actions, entitlements, and permitting necessary for the Project, numerous documents are required to be executed throughout the planning, permitting, and entitlement process relating to the Project and the Real Property with the City of Lakewood, County of Los Angeles, FAA, and Southern California Edison; and
- E. WHEREAS, it is the desire of the Board of Directors to authorize the General Manager to execute the documents listed in Exhibit "A" to this Resolution in order to facilitate the Project.

NOW, THEREFORE, the Water Replenishment District of Southern California herby resolves as follows:

- <u>Section 1</u>. <u>Incorporation of Recitals</u>. The foregoing Recitals are true and correct and are incorporated herein and form a part of this Resolution.
- Section 2. Approval of Agreements; Authority of General Manager. The General Manager is hereby authorized to execute all documents and agreements listed in Exhibit "A" to this Resolution, subject to the review and approval as to form by District Counsel.
