B. Consider Sponsorship of Fiscal Year 2024-25 Community Outreach Events

Recommendation:

Recommendation:

That the Board authorize the General Manager to execute Amendment 1 to the existing agreement by and among West Basin Municipal Water District, California Water Services Company and Palos Verdes Golf Club for the funding, design, and construction of the Palos Verdes Recycled Water Pipeline Project, barring any significant modifications to the draft provided in Attachment B.

E. Approval to Issue a Request for Bids for Construction Services for Fire Protection System Improvements Project (CIP-10130)

Recommendation:

That the Board authorize the General Manager to issue a Request for Bids for construction services for the Fire Protection System Improvements Project (CIP-10130) once the construction bid package is complete.

F. Approval to Award Temporary Dewatering System Pre-Rental Agreement, and Issue Request for Bids for Construction Services for the Solids Handling Improvements Project (CIP-10059)

Recommendation:

That the Board authorize the General Manager to:

- 1. Enter into a pre-rental agreement with Pace DS for the rental of a temporary dewatering system for a period of 12 months for an estimated total of \$912,118, with a 10% contingency of \$91,212, for a total-not-to-exceed amount of \$1,003,330 plus taxes and shipping costs.
- 2. Authorize staff to proceed with the procurement of MCC Electrical Breakers following West Basin's Administrative Code requirements for the Informal Competitive Solicitation of Goods, Professional Services, and Non-Professional Services (Administrative Code Chapter 5-1.103).
- 3. Issue a Request for Bids for construction services for the Solids Handling Improvements Project once the 100% Bid Documents have been reviewed and approved by staff.
- G. Procure Reverse Osmosis Membranes

Recommendation:

That the Board authorize the General Manager to procure 1,596 reverse osmosis membranes and spare parts from Toray Membrane USA for a total not-to-exceed amount of \$763,028 including shipping and sales tax.
