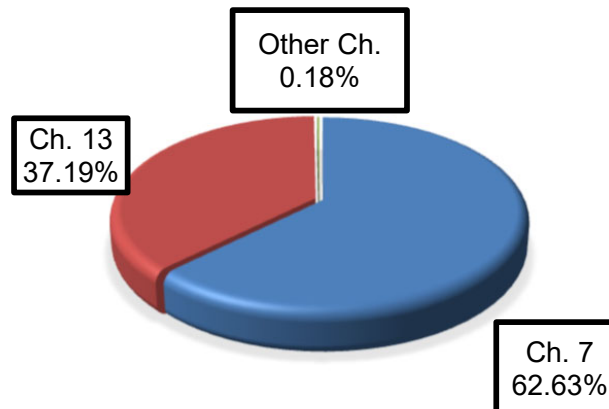

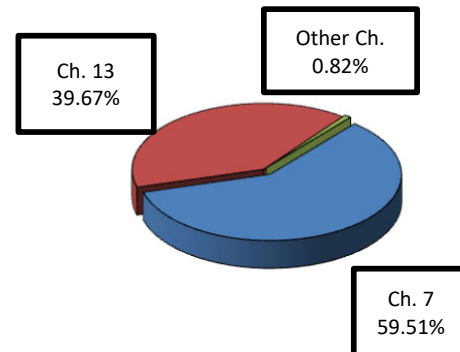

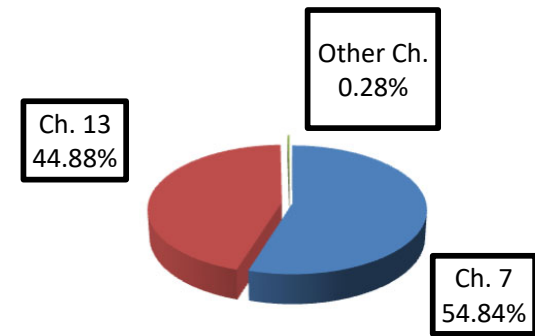
2024 CURRENT MONTH
