




New Cases by Chapter

Of those 270 cases were filed under Chapter 7, 4 cases were filed under Chapter 11 and 152 cases were filed under Chapter 13. There were no cases filed under any other Chapter. 
New Cases by Division

The chart below depicts the number of new cases filed per division in June, 2024.




New Adversaries by Division
