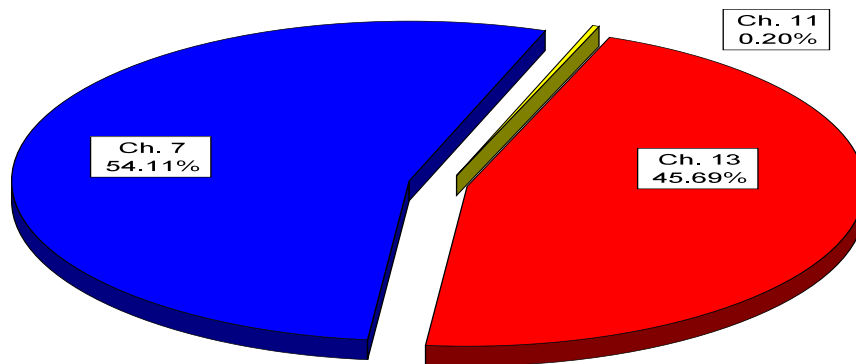

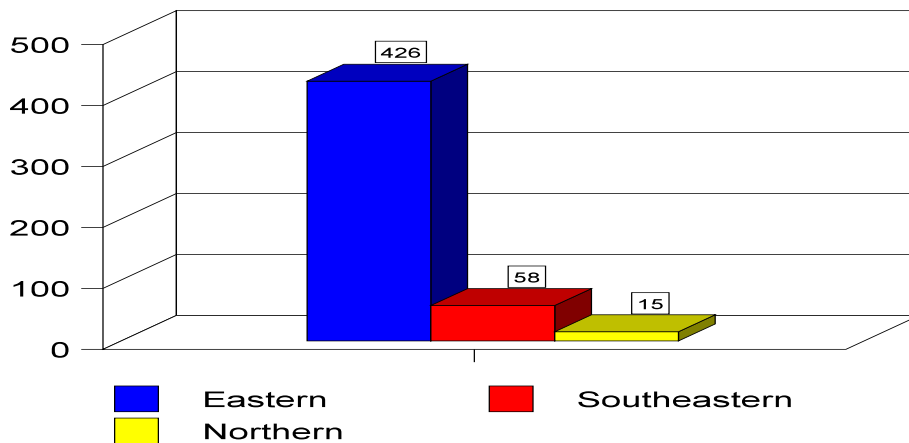
### New Cases by Chapter

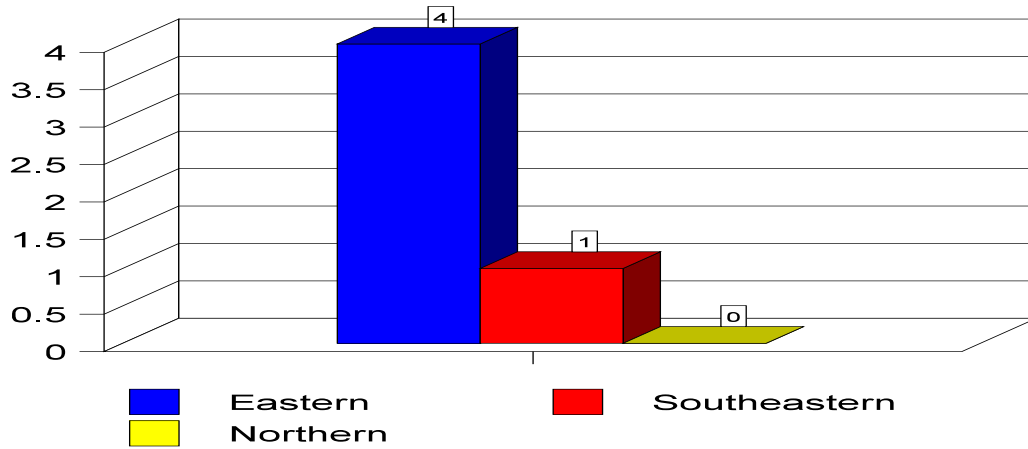
### New Cases by Division

The chart below depicts the number of new cases filed per division in August, 2024.



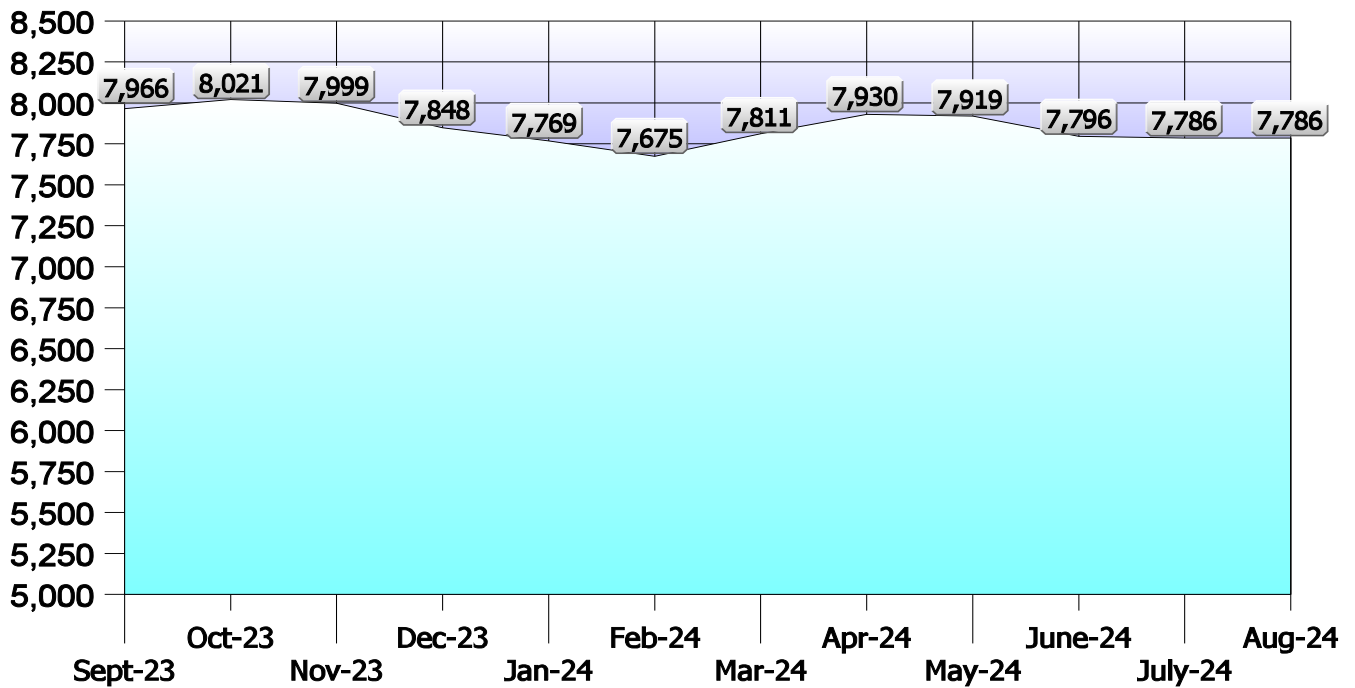
## New Adversaries by Division
