2024 Second-quarter ConocoPhillips Alaska earnings review

ANCHORAGE, ALASKA – In connection with ConocoPhillips' quarterly 2024 earnings announced earlier today, ConocoPhillips Alaska reported net income of \$360 million in the second quarter of 2024.

During the quarter, ConocoPhillips Alaska incurred an estimated \$411 million in taxes and royalties, which includes \$293 million to the State of Alaska and \$118 million to the federal government.

Additionally, in the second quarter of 2024, ConocoPhillips Alaska invested \$691 million in capital.

"The Willow project continues to advance, bolstering Alaska's economy and creating thousands of jobs. We are on schedule to achieve first oil by 2029, and we've achieved significant milestones at Willow with arrival of the Operations Center modules in Alaska and commencement of the Central Facility fabrication earlier than planned," stated Erec Isaacson, president of ConocoPhillips Alaska.

"The stable fiscal environment in Alaska encourages new and continuous business activity. Since January 2024, our investments in Alaska projects such as Willow and Nuna have exceeded \$1.4 billion, underscoring our sustained commitment to Alaska for more than 50 years."

Since 2007, ConocoPhillips Alaska has incurred approximately \$45 billion in taxes and royalties to the State of Alaska and the federal government. Of that amount, about \$35 billion went directly to the state. In that same period, ConocoPhillips Alaska's earnings were over \$27 billion.
