# Message from Our CEO



As we reflect on the past year at Houston Healthcare, it is clear that we have navigated a challenging healthcare landscape. Despite these difficulties, we have remained steadfast in our commitment to delivering exceptional care and expanding our services to meet the needs of our thriving community.

Our 2023 growth initiatives have been substantial. We welcomed a new da Vinci Xi Surgical robot to Houston Healthcare - Perry, expanding our robotic surgery program to the Perry community. Similarly, Houston Healthcare - Warner Robins acquired a third da Vinci Xi Surgical System. The Houston Healthcare Medical Office Building - Bonaire opened in fall, and we expanded our OB/GYN and family medicine services to the Bonaire community. Furthermore, Houston Surgical Associates, formerly Surgical Associates of Warner Robins, joined our team of employed physicians, and we welcomed robotically trained general surgeon Luke Couch, MD, to the practice as well. Additionally, we addressed physician shortages by welcoming John Zheng, MD, a board-certified otolaryngologist, to Houston ENT Associates, and two neurohospitalists to our team.

Our commitment to high-quality care is evidenced by our Houston Healthcare facilities receiving reaccreditation from DNV Healthcare USA, Inc. Additionally, Pavilion Diagnostic Center was recognized for its excellence in breast cancer diagnosis processes.

To enhance our ability to deliver exceptional care to the Houston County region, we entered a strategic partnership with Atrium Health Navicent to help impact our cost structure, quality, and information technology.

As always, our community partnerships are important to us. We were excited to support the new Roy H. "Sonny" Watson Wellness Complex at Central Georgia Technical College's Warner Robins Campus, which will host a variety of sports and student activities. Additionally, in recognition of our support of Middle Georgia State University's nursing programs, they named a nursing suite at their Warner Robins Campus, the "Houston Healthcare Nursing Suite." These partnerships reflect our commitment to community health and workforce development.

Our leadership landscape at the board level changed. We mourned the passing of three long-standing, highly esteemed board members. Mr. Roy H. "Sonny" Watson, Jr., Mr. Fred Graham, and Mr. James Edward Dyson, III contributed greatly to the growth and success of Houston Healthcare through their many years of dedication and service. Their leadership will be deeply missed, and we honor their memories by continuing to uphold the high standards they set.

We also welcomed five distinguished physicians to our boards of directors. Joining the Houston Healthcare System, Inc. Board, responsible for strategic planning, asset allocation, and compensation and benefits, were Mohammad Al-Shroof, MD, a board-certified internal medicine physician; John D.
