Cayman National Corporation Ltd. is pleased to announce Net Income of CI\$39.7M for the nine-month period to 30 June 2024. This performance is stable with the same period a year ago.

Total Income of CI\$86.4M has increased by 6% compared to the prior year. Operating expenses of CI\$47.3M have increased by 9% over the same period.

Total deposits increased by 11% compared to a year ago. The balance sheet remains very strong with Total Assets of CI\$2,041M increasing by 12%. Shareholders' Equity increased by 17% to CI\$248.8M as a result of growth in retained earnings over the prior year.

We are pleased with this solid performance to June 30, 2023, and will continue to strive to deliver value for all of our stakeholders.
