Policy

Responsible sourcing and purchasing practices are to be embedded in the sourcing and procurement of all trade products. These practices support decision making and processes that are aligned with:

- Kontoor's Terms of Engagement & Global Compliance Principles, Code of Business Conduct, Master Manufacturing Terms and Conditions agreement and any other policies and procedures that are applicable

- 3. Long term business partnership through collaborative initiatives in capacity planning, quality, and on-time delivery improvement
- National minimum wage requirement and promote living wage achievement by supporting collective bargaining and long-term retention of the workforce

- 3. **Time**: Provide enough time for suppliers to complete all processes in compliance to laws and relevant codes of conduct.
- 4. **Financials**: Use fair financial practices with suppliers.
- 5. **Shared Responsibility**: Do our part to improve working conditions and environmental performance the supply chain.
- 6. **Manufacturing Practices**: Support suppliers on quality improvement and garment engineering to increase operational efficiency.
- 7. **Training**: Educate Kontoor employees and suppliers on Responsible Sourcing and Purchasing practices.
