Pursuant to the share consolidation timetable issued by Chong Fai Jewellery Group Holdings Company Limited ("Chong Fai Jewellery"), the share consolidation of 10 existing shares of HK\$0.01 each in Chong Fai Jewellery into 1 consolidated share of HK\$0.1 each will become effective on 28 May 2024. Shareholders, investors and market participants should read the Chong Fai Jewellery's circulars and regulatory announcements in full including the terms and conditions of Chong Fai Jewellery's share consolidation in dealing with Chong Fai Jewellery's shares. If they are in doubt, they should consult their professional adviser(s).

As an OTP-C standard practice for share consolidation and for reference only, an Adjusted Previous Closing Price will be displayed in the "PRV CLOSE" field of Chong Fai Jewellery's OTP-C temporary stock page (stock code 8582) on 28 May 2024. Calculation of the Adjusted Previous Closing Price will be based on Chong Fai Jewellery's closing price on 27 May 2024 (i.e. the day immediately before the share consolidation becoming effective) and by using the following standard adjustment formula for share consolidation generally.

Adjustment Formula:

Adjusted Previous Closing Price

= Closing Price on the day immediately before Share Consolidation becoming effective x R

where:

R = Ratio of Share Consolidation, i.e. 10/1
