Pursuant to the capital reorganisation timetable issued by Wuxi Life International Holdings Group Limited ("Wuxi Life"), the capital reorganisation which comprises the share consolidation of 10 existing shares of HK\$0.04 each in Wuxi Life into 1 consolidated share of HK\$0.4 each and the capital reduction of nominal value of the consolidated shares from HK\$0.4 each to HK\$0.01 each will become effective on 9 July 2024. Shareholders, investors and market participants should read the Wuxi Life's circulars and regulatory announcements in full including the terms and conditions of Wuxi Life's capital reorganisation in dealing with Wuxi Life's shares. If they are in doubt, they should consult their professional adviser(s).

As an OTP-C standard practice for share consolidation and for reference only, an Adjusted Previous Closing Price will be displayed in the "PRV CLOSE" field of Wuxi Life's OTP-C temporary stock page (stock code 8589) on 9 July 2024. Calculation of the Adjusted Previous Closing Price will be based on Wuxi Life's closing price on 8 July 2024 (i.e. the day immediately before the capital reorganisation becoming effective) and by using the following standard adjustment formula for share consolidation generally.

Adjustment Formula:

Adjusted Previous Closing Price

= Closing Price on the day immediately before Capital Reorganisation becoming effective x R

where:

R = Ratio of Share Consolidation, i.e. 10/1

For illustration purpose, depending on Wuxi Life's closing price on 8 July 2024, the Exchange shall base on the above standard formula for share consolidation generally to calculate and display the Adjusted Previous Closing Price on Wuxi Life's OTP-C temporary stock page on 9 July 2024 as follows:-
