Pursuant to the timetable issued by Beijing SinoHytec Co., Ltd. ("Beijing SinoHytec") for the Capitalisation Issue, Beijing SinoHytec's H shares (stock code 2402) will be marked "ex-entitlement" on 4 July 2024, the Ex-Entitlement Date. Shareholders, investors and market participants should read the Beijing SinoHytec's regulatory announcements and circulars in full including the terms and conditions of the Capitalisation Issue in dealing with Beijing SinoHytec's H shares. If they are in doubt, they should consult their professional adviser(s).

As an OTP-C standard practice for ex-bonus issue and for reference only, an Adjusted Previous Closing Price will be displayed in the "PRV CLOSE" field of Beijing SinoHytec's OTP-C stock page on 4 July 2024, the Ex-Entitlement Date. The unadjusted previous closing price will instead be displayed in the free text field. Calculation of the Adjusted Previous Closing Price will be based on Beijing SinoHytec's closing price on 3 July 2024 (i.e. last cum-all trading day) and by using the following standard adjustment formula for bonus issue generally.

#### Adjustment Formula:

Adjusted Previous Closing Price

= (Closing Price on the last cum-all trading day x Y) ÷ (X + Y)

#### where:

X = Number of new H shares a shareholder is expected to receive when he/she holds Y existing H shares on the record date, i.e. 4 new H shares

Y = Number of existing H shares a shareholder has to hold on the record date for entitling him/herself to X new H shares, i.e. 10 H shares
