4.7C.1 Details of business activities for the quarter

In the previous quarter the Company announced that it had entered into a Merger Implementation Deed and a Share Sale Agreement to facilitate the acquisition of Scalare Partners Pty Ltd.

As part of the transaction, Shareholder approval was obtained at an Extraordinary General Meeting held on 23 September 2024 to:

- Undertake a share consolidation on a 56 for 1 basis. This was completed on 7 October 2024;
- Subject to completion of the transaction, change its name to Scalare Partner Holdings Limited;
- Undertake a capital raising to raise a minimum of \$4 million and up to \$8 million;
- Subject to completion of the transaction, issue 72 million ordinary CLB shares to the vendors of the Scalare business; and
- seek re-compliance with Chapters 1 and 2 of the ASX Listing Rules.

The Company continues to work with Scalare Partners to complete the acquisition with a Public Share Offer currently open and scheduled to close on 25 October 2024.

The Company will keep the market updated on the progress of the Share Offer and the re-compliance with Chapters 1 and 2 of the ASX Listing Rules.
