

# 5yr SPX Uncapped Dual Directional Accelerated Barrier Notes

The following is a summary of the terms of the notes offered by the preliminary pricing supplement highlighted below.

## Summary of Terms

Payment At Maturity: If the Final Value is greater than the Initial Value, your payment at maturity per \$1,000 principal amount

note will be calculated as follows:

\$1,000 + (\$1,000 × Underlying Return × Upside Leverage Factor)

If the Final Value is equal to or less than the Initial Value but greater than or equal to the Barrier Amount, your payment at maturity per \$1,000 principal amount note will be calculated as follows:

\$1,000 + (\$1,000 × Absolute Underlying Return)

This payout formula results in an effective cap of 30.00% on your return at maturity if the Underlying Return is negative. Under these limited circumstances, your maximum payment at maturity is \$1,300.00 principal amount note.

If the Final Value is less than the Barrier Amount, your payment at maturity per \$1,000 principal amount note will be calculated as follows:

\$1,000 + (\$1,000 x Underlying Return)

If the Final Value is less than the Barrier Amount, you will lose more than 30.00% of your principal amount at maturity and could lose all of your principal amount at maturity.


