Given the time required for YAL and Geek Plus to finalise the terms of the Renovation Agreement and in order to secure the preparatory works of Geek Plus, YAL entered into the Quotations for the floor levelling work and the installation of a shelving system with Geek Plus on 9 September 2024 and 14 October 2024 respectively.

Scope of work: Geek Plus shall deliver the Goods to YAL and complete the

installation of the Automated Warehouse System with warranty

service for 1 year.

Contract price and payment terms:

HK\$30,830,000 (i.e. the Robotic Agreement Price) (exclusive of the HK\$1,849,800 second year full coverage maintenance fee mentioned below), payable by YAL to Geek Plus in the following manner:

- (1) 30% of the Robotic Agreement Price shall be payable upon execution of the Robotic Agreement;

YAL agrees to appoint Geek Plus as contractor to provide the Work: Renovation Work for the Mapletree Warehouse.

Contract price and payment terms:

HK\$11,410,000 (i.e. the Renovation Agreement Price), payable by the Company to Geek Plus in the following manner:

- HK\$5,705,000 shall be payable upon signing of the (1)Renovation Agreement;
- (2) HK\$560,000 shall be payable upon completion of the floor levelling works;
- HK\$4,116,000 shall be payable upon the installation of the shelving system;
- HK\$1,029,000 shall be payable upon completion of all (4) shelving system related works.

The Renovation Agreement Price was and will be financed by internal resources of the Group.

Completion of work:

The Renovation Work shall be completed on or before 15 February 2025, unless otherwise agreed in writing between YAL and Geek Plus.

Given the time required for YAL and Geek Plus to finalise the terms of the Renovation Agreement and in order to secure the preparatory works of Geek Plus, YAL entered into the Quotations with Geek Plus on 9 September 2024 and 14 October 2024 respectively, pursuant to which (i) YAL paid the deposit of HK\$560,000 for the floor levelling work on 12 September 2024; (ii) YAL paid a sum of HK\$5,145,000 as deposit for the shelving system on 26 October 2024; and (iii) upon the entering into of the Renovation Agreement, the said deposits shall be applied towards the first installment of the Renovation Agreement Price. Hence, the aggregate consideration of the Agreements amounts to HK\$44,089,800.

The price of the Quotations were financed by internal resources of the Group.

INFORMATION OF THE GROUP AND GEEK PLUS

The Group is an online retailer headquartered in Hong Kong which engages in the procurement and sale of third-party branded and unbranded Asian fashion & lifestyle, beauty and entertainment products to customers around the world.

YA Logistics is a company incorporated in Hong Kong with limited liability and a wholly-owned subsidiary of the Company. It is principally engaged in the provision of logistics and warehouse services.

To the best of the knowledge, information and belief of the Directors having made all reasonable enquiries, (i) Geek Plus is principally engaged in the development of autonomous mobile robots and provision of warehouse fulfillment robotic solutions; (ii) neither the Company nor its connected persons is connected to Geek Plus or its ultimate beneficial owners.

REASONS FOR AND BENEFITS OF ENTERING INTO THE AGREEMENTS

As disclosed in the Company's announcement dated 17 May 2024 and the Company's circular dated 21 June 2024, YAL leased the Mapletree Warehouse to facilitate the plan to establish an additional autonomous mobile robotics ("AMR") warehouse. The Directors are of the view that it is in the interests of the Group to enter into the Agreements to establish the AMR warehouse at the Mapletree Warehouse so as to increase the Group's fulfilment capacity to cope with the future growth of our businesses. The new AMR warehouse is expected to start operating in April 2025.

The terms of the Agreements (including the consideration of each of the Agreements) were reached after arm's length negotiation with reference to the standard required for and expected quality of the Automated Warehouse System and Renovation Work, the experience and market position of the contractor, the prevailing market price of other warehouse fulfillment robotic solutions available in the market.

In view of the above, the Directors consider that the Agreements and the transactions contemplated thereunder were determined after arm's length negotiations among the parties thereto, are on normal commercial terms, fair and reasonable and in the interests of the Group and the Shareholders as a whole.

As one or more of the applicable percentage ratios in respect of the Agreements, on an aggregate basis, exceeds 5% but all of them are less than 25%, the transactions contemplated under the Agreements constitute discloseable transactions of the Company, and are therefore subject to the notification and announcement requirements under Chapter 14 of the Listing Rules.
