NOTE 1 - BUSINESS

Unitronix Corporation (the “Company”), was incorporated under the laws of the State of New Jersey on 09/1975. The Company is a cutting-edge blockchain technology company, dedicated to developing decentralized finance solutions that bridge the gap between traditional financial markets and the digital economy. With a focus on transparency, security, and innovation. Unitronix is creating new proprietary blockchain technology to serve investors and businesses in the rapidly evolving cryptocurrency financial landscape.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of presentation

The Company’s unaudited financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”). The accompanying unaudited financial statements reflect all adjustments, consisting of only normal recurring items, which, in the opinion of management, are necessary for a fair statement of the results of operations for the periods shown and are not necessarily indicative of the results to be expected for the next period. These unaudited financial statements should be read in conjunction with the financial statements and related notes in the Company’s financial statements for the annual ending June 30, 2024.

These Financial Statements are prepared on the basis of information provided by the Management of the Company, and the Management is responsible for the completeness and materiality of these financial statements.

Use of estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Cash and cash equivalents

The Company considers all highly liquid investments purchased with original maturities of three months or less to be cash equivalents.

Recently issued accounting pronouncements

The Company has implemented all new accounting pronouncements that are in effect. These pronouncements did not have any material impact on the financial statements unless otherwise disclosed, and the Company does not believe that there are any other new accounting pronouncements that have been issued that might have a material impact on its financial position or results of operations.

Revenue Recognition

The Company recognizes revenue when there is persuasive evidence of an arrangement, delivery has occurred, the fee is determinable, collectability is reasonably assured and there are no significant remaining performance obligations.

Income Taxes

Income taxes are accounted for under the assets and liability method. Current income taxes are provided in accordance with the laws of the respective taxing authorities. Deferred income taxes are provided for the estimated future tax consequences attributable to differences between the financial statement carrying amounts of existing assets and liabilities and their respective tax bases and operating loss and tax credit carry-forwards. Deferred tax assets and liabilities are measured using

enacted tax rates in effect for the year in which those temporary differences are expected to be recovered or settled. Deferred tax assets are reduced by a valuation allowance when, in the opinion of management, it is more likely than not that some portion or all of the deferred tax assets will be realized.

NOTE 3 - GOING CONCERN

The accompanying financial statements have been prepared assuming that the Company will continue as a going concern, which contemplates the realization of assets and the discharge of liabilities in the normal course of business for the foreseeable future. As of June 30, 2024, the Company's revenue is insufficient to cover its operating expenses. The company has \$139,186 in Total Assets and an accumulated deficit of \$8,377,843. The Company's ability to raise additional capital through the future issuances of common stock and/or debt financing is unknown. The obtainment of additional financing, the successful development of the Company's contemplated plan of operations, and its transition, ultimately, to the attainment of profitable operations are necessary for the Company to continue operations. These conditions and the ability to successfully resolve these factors raise substantial doubt about the Company's ability to continue as a going concern. The financial statements of the Company do not include any adjustments that may result from the outcome of these aforementioned uncertainties.

NOTE 4 – CURRENT AND NON-CURRENT ASSETS

As of June 30, 2024 the Company has \$18,722 in cash and cash equivalent. The Company \$6,364 in account payable. In addition, the Company holds IP valued at \$40,500 and investments of \$73,600, for a total of \$139,186 in assets.

NOTE 5 – CURRENT AND NON-CURRENT LIABILITIES

As of June 30, 2024, the Company has \$184,908 in account payables and a long-term loan of \$246,759 bearing a 5% annual interest. The company investment's funds were used to pay back loans for the amount of \$171,701.

As of June 30, 2024, the Company has no Notes Payables.

NOTE 6 – COMMON AND PREFERRED STOCK

The Company hasn't issued any common shares during this year and did not have any Preferred Stock issued and outstanding as of June 30, 2024.

NOTE 7 – OTHER ITEMS

1. Legal Proceedings - The company is not currently involved in legal proceedings.
2. The company has substantial net operating loss carry forwards for federal income tax purposes estimated at about \$8,395,302 through June 30, 2024. Due to the company's issuance of stock, the company's use of its existing loss carry-forwards may be restricted under Section 382 of the Internal Revenue Code.
