Dear Ladies and Gentlemen:

I write to provide the OTC Markets Group Inc. with an opinion with respect to the Company. OTC Markets Group Inc. is entitled to rely on such opinion in determining whether to permit quotations in the Issuer's securities (the "Securities") in the OTC Markets Group Inc. quotation venue and in deciding whether the Issuer has made adequate current information publicly available within the meaning of Rule 144(c)(2) under the Securities Act of 1933, as amended (the "Securities Act").

I am a U.S. resident and I have been retained by the Issuer solely for the purpose of reviewing the current information supplied by the Issuer. I do not own any shares of the Issuer's securities and will not receive any shares of the Issuer's securities as payment for services rendered, currently or in the future.

I have examined such corporate records, e.g. Articles of Incorporation, Bylaws, corporate minutes and other documents and such questions of law as I have considered necessary or appropriate for purposes of rendering this letter. I am authorized to practice law in the State of Ohio, including the laws of the United States. I am permitted to practice before the Securities and Exchange Commission (the "Commission") and have not been prohibited from practice thereunder.

I am not currently and have not been in the preceding five (5) years, suspended or barred from practicing in any state or jurisdiction, or charged in a civil or criminal case. I am not currently and have not been in the preceding five (5) years, subject of an investigation, hearing, or proceeding by the Commission, the U.S Commodity Futures Trading Commission ("CFTC"), the Financial Industry Regulatory Authority ("FINRA"), or any other federal, state, or foreign regulatory agency.

On September 20, 2024, the Issuer posted on the OTC Disclosure and News Service its Amended Annual Report for the Year Ended March 31, 2024, prepared in accordance with Rule 15c2-11(a)(5) promulgated under the Securities and Exchange Act of 1934 (the "Exchange Act"). I have reviewed all such

documents (the "Information") in connection with the preparation of this letter and find them to be suitable for public disclosure.

It is my belief that the Information (i) constitutes "adequate current public information" concerning the Securities and the Issuer and "is available" within the meaning of Rule 144(c)(2) under the Securities Act, (ii) includes all of the information that a broker-dealer would be required to obtain from the Issuer to publish a quotation for the Securities under Rule 15c2-11 under the Exchange Act, (iii) complies as to form with the OTC Markets Group Inc. Guidelines for Providing Adequate Current Information, which are located on the Internet at www.otcmarkets.com, and (iv) has been posted on the OTC Disclosure and News Service.

The opinion and conclusions herein are based upon documentation and facts made available to me by the Company and are based on the accuracy of those documents and facts. The documentation that was provided to me was believed to be true and reliable in its contents. Below is the information posted to the OTC Disclosure and News Service on June 30, 2024 which I have reviewed in rendering this opinion:

- 5. Statement of Changes in Stockholders' Equity for the years ended March 31, 2021 through 2024 (unaudited).
- 6. Notes to Financial Statements (Unaudited).

I personally met with Simon Littlewood, CEO and Director of the Issuer, to discuss and review the above documentation with management of the Issuer and with a majority of the Board of Directors. In the event that the facts and information in all such documents are determined not to be true, this opinion shall be null and void.

The Transfer Agent is listed with the Commission and also has Depository Trust Corporation approval. As of March 31, 2024, there were 10,221,526 shares of Common Stock issued and outstanding of the Issuer. The Company's Transfer Agent was the source of confirmation of the common shares outstanding of the Issuer, via email on September 19, 2024.

To the best of counsel's knowledge, after inquiry of management and the directors of the Issuer, neither the Issuer, nor counsel or any 5% holder is currently under investigation by any federal or state regulatory authority for any violation of federal or state securities law.

The Company was incorporated in the State of Nevada on March 12, 1999; however, the Company did not file public information with OTC Markets Group, Inc. until 2009. Therefore, I cannot determine if the Company was a "shell company" as defined in Rule 405 of the Securities Act and Exchange Act during that timeframe in which public information is unavailable. Moreover, in 2019, the Company classified itself as a "shell company." The Company has never been a reporting issuer with the Commission.

Currently, the Company serves as an investment platform for fintech (digital and carbon credit exchanges, certifiers, tokenization businesses, incubators and other solution providers) and sustainable solutions (food and agriculture, energy, housing, new materials, resources, health, education, media, entertainment, etc.). While the Company is headquartered in Reno, Nevada, it has offices and partners located in Africa, the Middle East, Latin America, the Caribbean, Asia and Europe.

In its Amended Annual Report for the year ended March 31, 2024, the Company indicates it is not a "shell company" as it is pursuing an identified business plan; maintains assets valued at \$9,428.00 and reported operating expenses of \$59,237.00. Accordingly, I believe the Company is not currently a "shell company" and more information about the Company's business operations is available on its corporate website, www.pluralihg.com.
