Security Description

Common Stock

Each share of Common Stock is entitled to one vote. Shareholders do not have any pre-emptive rights. Dividends, if any, are declared by the Board of Directors. The Board of Directors has the power to issue stock on whatever terms they deem appropriate in their sole judgement without recourse to shareholders. The Board has the power to put restrictions on the transferability and registration of the stock.

Preferred Stock

The holder of each share of Series A Preferred Stock ("**Pref Stock**") has the right to one vote for each share of Common Stock into which such Pref Stock could be converted, on an as-converted basis, and with respect to such vote, such holder shall have full voting rights and powers equal to the voting rights and powers of the holders of Common Stock, and shall be entitled to notice of any stockholders' meeting.

The Pref Stock is non-redeemable other than upon the mutual agreement of the Company and the holder of the Pref Stock to be redeemed.

The Pref Stock is convertible, at the option of the holder thereof, at any time into such number of fully paid Common Stock as is determined by dividing the original issue price (\$0.001) by the conversion price per share of \$0.00002 (the “**Conversion Price**”). Each share of Pref Stock shall automatically be converted into shares of Common Stock at the Conversion Price immediately upon the earlier of (i) the Company’s sale of its Common Stock in a public offering pursuant to a registration statement (ii) a liquidation, dissolution or winding up of the Company; or (iii) the date specified by written consent or agreement of the holders of a majority of the then outstanding shares of Pref Stock.

Pref Stock holders are entitled to receive dividends upon any payment of any dividend (payable other than in Common Stock or other securities and rights convertible into or entitling the holder thereof to receive, directly or indirectly, additional shares of Common Stock of the Company) on the Common Stock of the Company, as and if declared by the Board of Directors, as if the Pref Stock had been converted into Common Stock

In liquidation, dissolution, or winding up, Pref Stock holders are entitled to receive, prior and in preference to any distribution of any of the assets of the Company to the holders of Common Stock, an amount per share equal to the price per share actually paid to the Company on the initial issuance of the Pref Stock plus declared but unpaid dividends. The remaining assets shall be distributed to the holders of the Common Stock until such time as the holders of the Common stock shall have received a return of the capital originally contributed thereby. Thereafter, if assets remain in the Company, all remaining assets shall be distributed to all holders of Common Stock and Pref Stock, pro rata based on the number of shares of Common Stock held by each (assuming conversion of all such Pref Stock into Common Stock).

An acquisition of the Company or sale of substantially all the assets shall be treated as a liquidation.

For so long as at least an aggregate of 200,000 shares of Pref Stock are outstanding, the Company shall not without first obtaining the approval of the holders of at least a majority of the then outstanding Pref Stock:

- (a) amend or repeal any provision of the Company’s Articles of Incorporation or bylaws if such action would materially and adversely change the rights, preferences or privileges of the Pref Stock;
- (b) increase or decrease (other than by redemption or conversion) the total number of authorized shares of Pref Stock; or
- (c) redeem shares of Common Stock.

There have been no material modifications to the rights of Common nor Preferred Stock holders during the reporting period.

4) Issuer's Business, Products and Services

A. Summarize the issuer's business operations.

The Company is an investment, finance and advisory group, focused on the sustainability and finance sectors. It invests in, partners with and builds businesses in the finance and sustainability sectors.

B. List any subsidiaries, parents, or affiliated companies.

The Company has a number of partnerships and cooperative agreements with businesses in the US and overseas. The Company's President is affiliated with several businesses.

C. Describe the issuers' principal products or services

The Company focuses on investing in, financing and advising sustainable businesses, technology, projects, foundations, organizations and funds globally.

The Company has identified several areas where it believes there are opportunities, and is investing in, building, designing and partnering with others to develop those opportunities, using both traditional and digital financing tools and products.

- Carbon Finance – the Company believes this is an area that will expand rapidly, as it believes regulations globally, and particularly in the US, will increasingly require businesses and other organizations to account for and reduce their carbon footprint. The Company believes there will be a significant expansion of carbon credit programs, in particular voluntary carbon credits, and increasing use of carbon credit finance by projects generating carbon credits in Developing Economies. The Company is in discussions with several organizations in the carbon credit and carbon finance sector, and with project owners that have the potential to generate carbon credits.
- Digital Finance – the Company believes that digital finance will be an important part of the financing of sustainable businesses, technologies and projects, especially businesses and projects based in Developing Economies. The Company is in discussions with several digital exchanges and technology providers globally with a view to partnering with them for listing the products we are creating, and the companies we are working with and investing in.
- Bespoke funds and investment vehicles – the Company is in discussions with several fund managers about partnering for the launch of industry or geographically focused funds in areas where the Company's management team and network can add value. The Company intends to tie up relationships with partners in different geographical regions and sectors to maximize the access to investors and deal flow. The Company has a cooperation agreement with Texas based 1847 Ventures for creating bespoke funds in the US, and with European based BAC for European, Middle East and African focused funds.
- Cross border consulting and business development – the Company is currently working with several businesses that are seeking to enter international markets or trade and other finance for international trade. The Company is working with groups in the Middle East, Central Asia, US, Europe, Africa, SE Asia and China.
- Reporting, Compliance & Monitoring – there are constantly increasing reporting and compliance requirements related to carbon, biodiversity, ESG, SDG and financial and other data. The Company is working with a number of solution providers to provide data and compliance services and solutions.

Implementing the above business models requires a significant expansion of the Company's operations, in particular personnel and capital. The Company is seeking to raise capital and bring on additional management resources and partners, but there is no guarantee that suitable staff, partners or funding will be available to implement the above plans in part or at all.

NOTES TO FINANCIAL STATEMENTS
FOR THE YEAR TO MARCH 31, 2024 and 2023

Note 1 – Organization and basis of accounting

Basis of Presentation and Organization

Plural Industry Holding Co Ltd. (the "**Company**") was established in Nevada in March 1999. The Company invests in and provides consulting services to businesses.

On November 19, 2019, a Motion to Appoint Custodian was filed in the Eighth Judicial District Court, Clark County, Nevada. On January 9, 2020, Custodian Ventures, controlled by David Lazar ("**Lazar**"), was granted Custodianship of the Company. On September 16, 2020, an Order was entered Terminating Custodianship of the Company and Lazar became the sole officer and director of the Company. On February 5, 2021 Lazar, the managing director of Custodian Ventures, sold his controlling interest in the Company of 10,000,000 Shares Series A Preferred Stock to Plural Industry Holding Group Co. Limited for \$200,000.

In February 2022, the Company's officers and members of the Board of Directors resigned, and were replaced by Simon Littlewood as President, Guodong Chai as Treasurer, and Zhongji Liu as Secretary.

The accompanying financial statements are prepared on the basis of accounting principles generally accepted in the United States of America ("GAAP"). The Company is a development stage enterprise devoting substantial efforts to establishing a new business, financial planning, raising capital, and research into products which may become part of the Company's product portfolio. The Company has not realized significant sales through since inception. A development stage company is defined as one in which all efforts are devoted substantially to establishing a new business and, even if planned principal operations have commenced, revenues are insignificant.

The accompanying financial statements have been prepared assuming the continuation of the Company as a going concern. The Company has not yet established an ongoing source of revenues sufficient to cover its operating costs and is dependent on debt and equity financing to fund its operations. Management of the Company is making efforts to raise additional funding. While management of the Company believes that it will be successful in its capital formation and planned operating activities, there can be no assurance that the Company will be able to raise additional equity capital or be successful in the development and commercialization of the products it develops or initiates collaboration agreements thereon. The accompanying financial statements do not include any adjustments to reflect the possible future effects on the recoverability and classification of assets or the amounts and classification of liabilities that may result from the possible inability of the Company to continue as a going concern.

Note 2 – Summary of significant accounting policies

Cash and Cash Equivalents

For purposes of reporting within the statements of cash flows, the Company considers all cash on hand, cash accounts not subject to withdrawal restrictions or penalties, and all highly liquid debt instruments purchased with a maturity of three months or less to be cash and cash equivalents.

Income Taxes

The Company accounts for income taxes pursuant to FASB ASC Topic 740, *Income Taxes*. Under FASB ASC Topic 740, deferred tax assets and liabilities are determined based on temporary differences between the bases of certain assets and liabilities for income tax and financial reporting purposes. The deferred tax assets and liabilities are classified according to the financial statement classification of the assets and liabilities generating the differences.

The Company maintains a valuation allowance with respect to deferred tax assets. The Company establishes a valuation allowance based upon the potential likelihood of realizing the deferred tax asset and taking into consideration the Company's financial position and results of operations for the current period. Future realization of the deferred tax benefit depends on the existence of sufficient taxable income within the carry-forward period under the Federal tax laws.

Changes in circumstances, such as the Company generating taxable income, could cause a change in judgment about the reliability of the related deferred tax asset. Any change in the valuation allowance will be included in income in the year of the change in estimate.

Employee Stock-Based Compensation

The Company accounts for stock-based compensation in accordance with ASC 718 Compensation - Stock Compensation ("ASC 718"). ASC 718 addresses all forms of share-based payment ("SBP") awards including shares issued under employee stock purchase plans and stock incentive shares. Under ASC 718 awards result in a cost that is measured at fair value on the awards' grant date, based on the estimated number of awards that are expected to vest and will result in a charge to operations.

Estimates

The financial statements are prepared on the basis of accounting principles generally accepted in the United States of America. The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities as of the relevant reporting dates, and expenses for the reporting period, and cumulative from inception. Actual results could differ from those estimates made by management.

Subsequent Event

The Company evaluated subsequent events through the date when financial statements are issued for disclosure consideration.

Recent Accounting Pronouncements

The Company believes it has implemented all new accounting pronouncements that are in effect and that may impact its financial statements and does not believe that there are any other new accounting pronouncements that have been issued that might have a material impact on its financial position or results of operations.

Consulting fees of US\$30,000 were paid to companies associated with the President for work performed during the reporting period.

In March 2020 the Company issued 10,000,000 shares of Series A Preferred Stock to Custodian Ventures, LLC in exchange for settlement of a portion of a related party loan. In February 2021 Plural Industry Holding Group Co. Limited acquired all 10.0 million.
